## NADCOM to RLW-NADO

REGIONAL SCHOLARSHIP FUND GRANTS--DENOMINATIONAL SCHOOLS

During the presentation of the Regional Scholarship Fund Grants for 1988 discussion ranged over a variety of aspects of the plan such as the criteria used in choosing the young people who benefit from this assistance, the procedures followed by the Regional Scholarship Fund Committee whether grants were made to a denominational employee's children, the finanancial sources of the fund, and how the young people apply for scholarship assistance. 88-26 February 25, 1988 - NADCOM

R L Woodfork responded to the questions outlining the application procedure, and explained that the financial provision is the equivalent of 2 percent of the 20 percent of tithe remitted to the General Conference by the Regional Conferences. In the case of an employee's children, if there are two young people equally eligible (one the child of an employee and the other not), the assistance is given to the nonworker's child. He also pointed out that the granting of Regional Scholarship assistance has never been contingent on the student's attending Loma Linda University. The Regional Scholarship guidelines are used in determining who will receive scholarship grants.

G Gordon Hadley read quotations from the Spirit of Prophecy which state that Adventist children and young people should secure their education in denominational schools. He was particulary concerned because so few of those granted scholarships are attending Loma Linda University. He stated that provision should be made so that all young people desirous of medical training would find it possible to attend Loma Linda University.

Other comments were made in this regard, some stating that in the past Loma Linda University did not welcome Black students. The thought was expressed that the whole matter of regional scholarships should be restudied.

The question arose regarding scholarship assistance for Hispanic young people. There is a Hispanic Scholarship Fund and applications are processed through the office of Joseph Espinosa who is the director of North American Missions. It was agreed it would be well for these lists of scholarships also to be brought to NADCOM for final approval.

Following the lengthy discussion, it was

VOTED, To request the North American Division Officers to appoint an <u>ad hoc</u> committee to give study to the Regional Scholarship Fund Grants, suggesting the following terms of reference as guidelines:

1. Consider issues beyond education inasmuch as Regional Scholarship Fund Grants have a broader purpose than enabling young people to secure an education.

2. Consider the value of increasing the number of church members with professional skills in Black communities.

3. Encourage Black and Hispanic young people to attend Loma Linda University whenever possible.

Evaluate the present system of financial assistance for scholarships.
