DEVOTIONAL

"Then he said to them, 'The Sabbath was made for man, not man for the Sabbath. So the Son of Man is Lord even of the Sabbath.'"—Mark 2:27 NIV We have been blessed and enobled by the Sabbath, but we have not really grasped how to fully reveal the Sabbath to others. The Chairman commented that he used to provide many proof texts to prove that the seventh day is the Sabbath, but he no longer feels this is adequate. Ellen G White wrote, "And at the commencement of the time of trouble, we were filled with the Holy Ghost as we went forth and proclaimed the Sabbath more fully," (EW 33) thereby expressing the fact that there is a wider connotation to the Sabbath truth than we have heretofore proclaimed.

Listen to how the prophet Isaiah expands on the Sabbath truth when he says, "This is what the Lord says: 'Maintain justice and do what is right, for my salvation is close at hand and my righteousness will soon be revealed. Blessed is the man who does this, the man who holds it fast, who keeps the Sabbath without desecrating it, and keeps his hand from doing any evil.'"—Isa 56:1-3 NIV May the Holy Spirit assist us as we attempt to reveal the Sabbath more fully to those about us.

PRAYER

Warren L Johns offered prayer and remembered the prayer requests for the major evangelistic campaign being conducted in Detroit, Michigan by C D Brooks and for Jacob Mittleider who was to be flown to the Loma Linda Medical Center yesterday.

REPORTS

Several of the committee members reported on the recent board meeting at Andrews University. They pointed out that the only way out of the financial impasse is to reduce programs and learn to operate with less. The administration is working hard to achieve this. It realizes it needs to find better ways to become more efficient.

Andrews University was authorized to go ahead with building Harrigan Hall for the School of Technology. The money is in hand for this including an endowment to cover the operating expenses of the building.

Gordon Madgwick suggested that our colleges and universities may need to effect a change in the structure of their boards. Because it is difficult to handle some problems with boards that are as large as the present boards, it may be better to provide more authority to the executive committees of these boards, the committee usually being composed of only 16 or 17 members rather than 60. This executive committee with additional authority could meet more often and handle problems more quickly, but it would be necessary to keep the larger board fully informed of what is going on by providing the members with agendas, minutes, and updates.

Five college administrators will be replaced within the next few months. William Loveless, President of Columbia Union College, has accepted the position of senior pastor at the Loma Linda University Church. Robert Williams, Provost at Kettering College of Medical Arts, will be retiring; and Peter Bath, the church pastor, will replace him as Provost. H J Bergman, President of Walla Walla College, will be returning to the classroom and will be replaced by Niels-Erik Andreasen, currently Dean of the School of Religion at Loma Linda University. Norman J Woods, President of Loma Linda University, and R Dale McCune, Chancellor of the Riverside Campus, have resigned. The search committee has nominated Fritz Guy to replace Dale McCune on the Riverside Campus.

Accrediting associations want to be informed in advance of substantive changes in programs and organization. College and university trustees and administrators need to keep this in mind before substantive changes are effected.

Monte Sahlin reported on his recent trip to South Africa. He indicated that most people there feel very uncertain about the future. Rapid changes are taking place that are impacting the Church. He was encouraged by many things that he experienced but is sure that solutions will not be simple. Student leadership at Helderberg College, where he conducted a week of prayer, very much favors integration and is doing an excellent job of incorporating students of all races into the college family.

HARVEST 90 - REPORT

Citywide evangelistic campaigns are being conducted in Detroit and New Orleans. Nine meetings are being held simultaneously in New Orleans.

Many conferences are reporting more baptisms in 1989 than they had in 1988. Hyveth Williams, now pastoring in the Boston area, has 250 in attendance at her church where formerly there were 40. The Lord is truly blessing.
