NAD 13TH SABBATH OFFERING PROJECT— FOURTH QUARTER 1995

An Adventist Health Network Meeting was held in connection with the Church Ministries Convention in St Louis in January 1995 to discuss the proposal to establish community health programs in ten cities in the North American Division. Suggested cities are as follows: Atlanta, Boston, Washington DC, Calgary, Philadelphia, Chicago, St Louis, Portland, Dallas-Fort Worth, San Francisco, and Los Angeles. These programs will be preventive in nature and should be operated jointly by Adventist Health Care and Church organizations utilizing the funds received from the fourth quarter 1995 Thirteenth Sabbath Offering.

The objective of these projects is to revitalize local community health outreach and the initial guidelines set forth are as follows:

- 1. The churches, conferences, and unions must participate in the project.
- 2. The local organizations must show a capacity for long-term commitment to the project.
 - 3. The program must be multi-cultural.
 - 4. It must be demonstrated that all entities are involved.
- 5. All North American Division conferences which share a common metropolitan area are encouraged to participate.
 - 6. There must be a commitment that it will be a model for future projects.

VOTED, To approve the concept to establish a health-related program which will be funded by the Thirteenth Sabbath Offering in the fourth quarter of 1995 with the

understanding the such programs will be operated jointly by the Seventh-day Adventist Church and the Adventist Health Care System.

VOTED, To ask the North American Division President to appoint a small committee which will function as a Steering Committee in the implementation of the proposals for the Community Health Program which will be operated jointly by the Seventh-day Church and the Adventist Hospital System.

VOTED, To request the NAD Health and Temperance Director to develop proposals for the Adventist Health Network and the Year of Health and Healing 1997, and to refer these proposals to the Steering Committee mentioned above.
