## East Pennsylvania Re-elects Elder T. E. Unruh

THE 20th biennial constituency convention of the East Pennsylvania Conference re-elected Elder T. E. Unruh to his seventh two-year term as president on Sunday, July 6, at Blue Mountain Academy.

Members of the conference executive committee elected included Elder T. E. Unruh, Elder V. A. Fenn, Elder J. M. Clemons, Elder Stephen Pauly, Elder J. L. Hamrick, Elder R. R. Adams, Dr. E. Zerme, Donald Woolever, and Ira Mills. The last three named are laymen.

### "War in Any Form"

ONE section of the Selective Service Questionnaire which must be filled out by every young man is somewhat confusing. It is Series VII of the Selective Service Classification

Questionnaire. It reads as follows:

Series VII.—CONSCIENTIOUS OBJECTION TO PARTICIPATION IN WAR IN ANY FORM INSTRUCTIONS.—You should complete this series by signing the statement below, requesting a Special Form for Conscientious Objector (SSS Form No. 150), from the local board, if, by reason of religious training and belief you are conscientiously opposed to participation in war in any form. Do not sign this series until you have read carefully.

BY REASON OF RELIGIOUS TRAINING AND BELIEF I AM CONSCIENTIOUSLY OPPOSED TO PARTICIPATION IN WAR IN ANY FORM AND FOR THIS REASON HEREBY REQUEST THAT THE LOCAL BOARD FURNISH ME A SPECIAL FORM FOR CONSCIENTIOUS OBJECTOR (SSS FORM NO. 150) WHICH I AM TO COMPLETE AND RETURN TO THE LOCAL BOARD FOR ITS CONSIDERATION.

Because of the fact that signing this part of the Questionnaire indicates that the individual thus signing is opposed to "war in any form" some of our young men have become confused. We are *not* opposed to *non-combatant* participation in war. Ever since we have declared ourselves to be noncombatant we have indicated our willingness to serve in a non-combatant capacity in harmony with our religious conviction. However, the Selective Service System and the Armed Forces have only *one* name for the man who will not bear arms. That name is "conscientious objector."

All young men who are in harmony with our denominational position on war should sign Series VII. Thus they will take the first step in securing their 1-A-O classification.

• ELDER C. L. Duffield reports that the recently closed 22-night series of evangelistic meetings in Springfield

were a success. His report reads in part:

We opened in Springfield with an attendance of 165 and did not have an "off" crowd for 22 straight nights. The attendance kept growing to the very end. The last three nights were the largest—Friday night, 225; Saturday night, 245; and Sunday night, 275—which filled the church with more than 75 in our little balcony.

"Seventeen have been baptized thus far and we will have another baptism next Sabbath, which should bring the total to 30 or more. Still other interests will be followed up."

Associated with Elder Duffield have been Elder Harold Wernick, the Springfield pastor, and Elder and Mrs. Donald Riesen, who have furnished the music for the series.

Elder Duffield emphasizes that the strong, well-organized leadership of Elder Wernick was a prime factor in the success of the meetings.

• Glenn Hill, pastor of the Hillsboro and Manchester district, informs us that seven have been baptized as a result of an effort held in the Manchester Church during recent weeks. This baptism is just the firstfruits from the effort. ### Grafton Revival Meetings

WE had fourteen church revivals scheduled for May and June. Grafton was one of the last in the series. It turned out to be one of the best. The meetings were conducted in the Grafton Church by E. A. Roberts of Logan, assisted by R. H. Shepard, our ministerial intern.

Speaker of the meetings, Bro. Roberts writes: "The Lord blessed beyond our expectations. Each evening I made a call and the response was just wonderful. We started the first night with an attendance of 27. This was a bit disappointing, so I said to Dick, 'We'll have to do a lot of visiting.' This we did, and on the last Sunday night 77 people came out. The hall was just packed solid. When we made a call the Lord really blessed, and five individuals came forward requesting baptism and church membership."

In recounting the experience at Grafton, Bro. Shepard writes: "We had an intense visiting program during the week. We visited all the church members at least once. We saw the results of our visitation in the increased attendance at the night meetings. It really looked good to see the church filled to capacity the last two nights and the members are thrilled with the results."

THE big event this spring for the members of the Williamsport district has been the opening of the new school building located just a few blocks from the church at Fleming and East Southern Avenues.

Though only the classrooms have been completed, and much interior finishing remains to be done in the other rooms, the children have appreciated the large, bright classrooms after experiencing the confinement of the church basement.

New desks captured the eyes of 31 children as they began school last fall. Now these desks add a bright touch to the modern school rooms. Every boy and girl worked to raise the funds for their purchase. Directed by Kathryn Ertel, the children have sold seeds, candy, and eggs to cover the cost of the desks. No one will ever be able to say that the adults did it all in Williamsport.

As soon as we catch our breath financially, we plan to finish off the interior of the gymnasium and workshop. The Dorcas Society ladies already are well along with their fund-raising projects which will meet the cost of the floor and finishing touches needed in the kitchen and welfare room.

The neighbors have marveled at what we have been able to accomplish with so little. We have heard many favorable comments on our "pay-as-you-build" plan. Truly the entire project is a tribute to the spirit of sacrifice and devotion of the members.

If you were to pass this church on Saturday evening, you would see everything bustling with activity. Following the MV meeting at 7:00, the Pathfinder Club takes over the downstairs of the church, and Joe Bausinger, director, sees to it that every corner is occupied by some activity. Archery and crafts of every sort interest eager young hands. You might see Kenneth Grove marching the club members back and forth like a real drill sergeant. Leon Ertel and Brother and Sister Paul Grove also lent a hand in keeping the green-and-khaki-uniformed "livewires" too busy to get into mischief. Best of all is the spiritual emphasis as young hearts pray and play together, making the Word of God their center of interest.

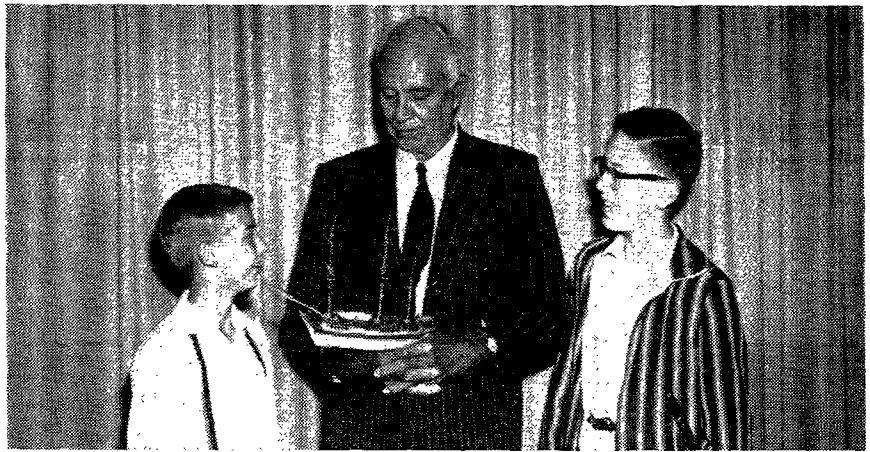

At present three laymen and their wives are conducting regular Bible studies with interested folk. A number of others are working through other direct soul-winning activities. We long for the time when many souls will crowd the church in preparation for the return of Jesus.

in the elementary, intermediate and secondary levels, and Whereas we feel constrained of God to make the necessary sacrifices to provide adequate facilities for our youth and thus aid them to maintain a faithful Christian experience, be it there Resolved":

Then followed twelve actions to implement the request of the constituency of this conference. This expansion program has already begun in many of the districts and churches throughout the New Jersey Conference from north to south, from east to west.

At the forthcoming camp meeting a special constituency meeting has been called. We believe that our entire conference will arise as one man to rally around this expansion for which they prayed. We are confident that they will support it with their faithful assistance, through their earnest prayers, attendance at our schools and gifts.

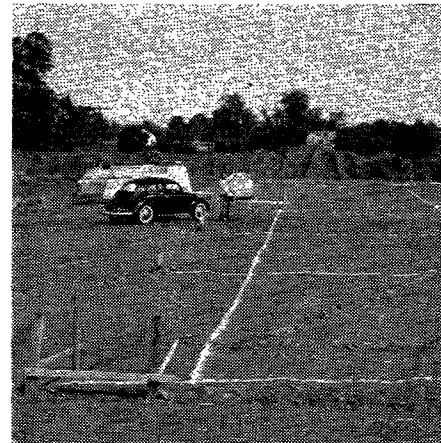

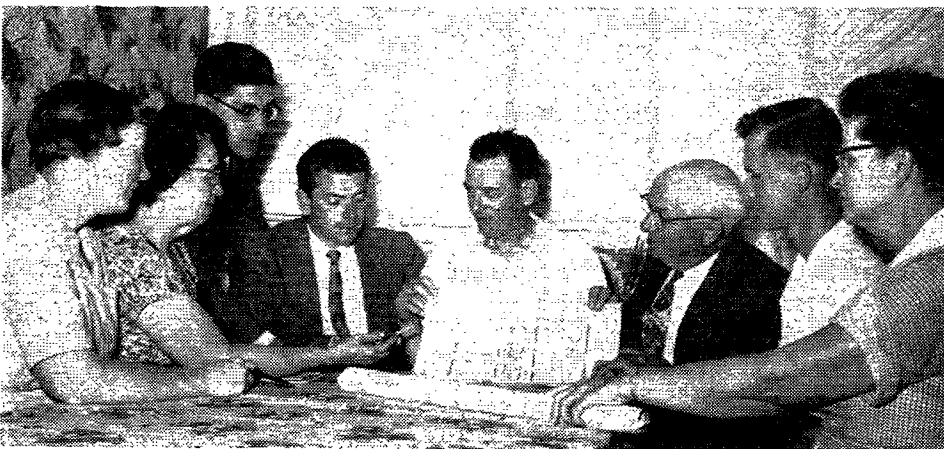

The Salem school is bulging with active boys and girls.

Farther north we come to the central part of the conference,—Trenton



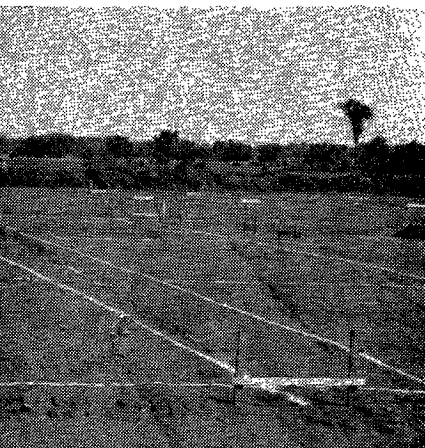

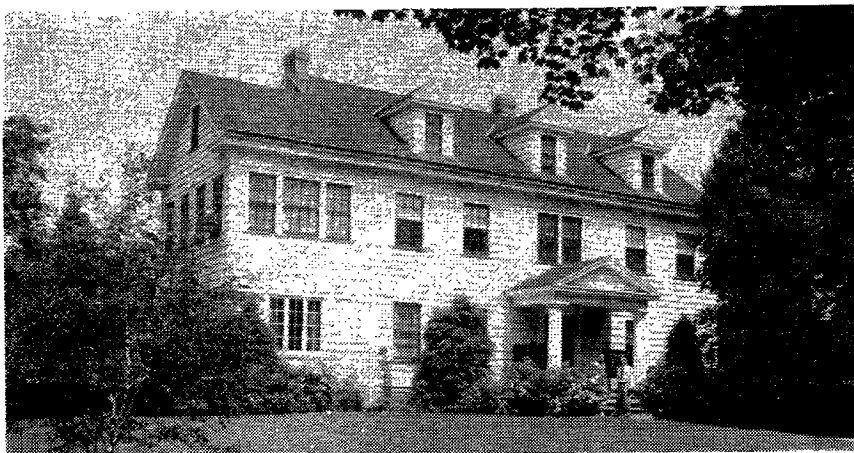

Now you have crossed the state  
from west to east, and we are on the  
beautiful eastern shore at Perth Am-  
boy. Here the faithful believers, re-

Across the Hudson from New York,  
we find the Newark area. Last year  
they operated a one-teacher school;  
but realizing the need of gathering  
a more of their children, they are

cated at Paterson and Hackensack.  
Both of these churches operated very  
fine two-teacher schools last year.  
Now the two districts are giving  
study to the possibility of a new union  
school for their two areas. In the  
picture you see representatives from  
various churches in these two dis-  
tricts, as they are studying the vari-  
ous details arising out of a united  
district school; such as, location,  
building and erecting a new plant.  
Committees on constitution, by-laws,  
finance, building plans and location  
are being set up.

Thus you see from north to south,  
and east to west, the educational pro-  
gram is expanding here in the New  
Jersey Conference. Six new teachers  
are joining the teaching staff for this  
next school year.

Several of the schools mentioned  
previously are adding ninth and  
tenth grades to their program. The  
elementary and intermediate expan-  
sion program is only part of the over-  
all picture. The secondary education  
is also in the process of expansion  
and development. With the gradua-  
tion of the 1958 class, the "Plainfield  
Academy" closed its doors. But the

doors are now open even wider as  
the new "Garden State Academy"  
gets under way. As the first step in  
this program, a beautiful building  
has been purchased to serve as a  
girls' home. Several additional teach-  
ers have been added to their faculty,  
including a music staff. Great plans  
are under way for the "Garden State  
Academy" for this coming school  
year, and even greater plans for the  
future.

The New Jersey Conference has set  
as its objective to have every Sev-  
enth-day Adventist young person in  
our own Christian schools. In order  
to implement this far-reaching pro-  
gram, the conference has voted a  
very liberal allowance to help the  
churches in their purchase of vehi-  
cles for transportation. Perth Amboy  
is the first to purchase such equip-  
ment in the form of a school bus.  
Other districts are planning to se-  
cure similar equipment to enable all  
of their children to be in church  
schools this coming year. This is a  
heavy schedule, and we ask the faith-  
ful believers of the Columbia Union  
to remember the New Jersey educa-  
tional program in their prayers.
