Your Committee on Resolutions would respectfully submit the following report:-

Whereas, A special effort is being made to extend the circulation of the Signs of the Times; therefore, —

1. Resolved, That we, the members of this society, reconsecrate ourselves to the missionary work, resuming the circulation of tracts; pamphlets, and especially the Signs of the Times, securing subscriptions and the sale of this valuable periodical.

Whereas, The American Sentinel is a periodical eminently well calculated to meet the live issues of the day; therefore,—

2. *Resolved*, That we give it our hearty support, and make all reasonable efforts to extend its circulation.

Whereas, The periodical business is somewhat complicated in certain localities by doing its work through a local agent aside from their librarian'; therefore,—

3. *Resolved*, That the office of local periodical agent be discontinued, and that the periodical business be transferred through the librarian of the local societies, and in places where there are no societies organized, that such societies be formed and librarians elected.

Whereas, The financial depression of the times requires economy in all branches of our work to insure success, and inasmuch as there is considerable loss to the cause by a failure on the part of many to do their periodical business through the librarians, and by renewals for a short period; therefore,—

4. Resolved, That as far as possible, the periodical business be done through the proper agent, and where that is impracticable the order for renewals be accompanied with cash (if possible) and for the longest time within the means of those making the order. Yearly subscriptions are recommended as far as possible.
