## Hawaiian Disaster Is Only the Beginning of Contacts

On Sabbath, February 1, a severe storm struck the windward Oahu town of Kaneohe. In one two-hour period, some 20" of rain fell!

Normally a placid waterway, the Kaneohe Stream, which runs through the town, rose quickly, the angry waters lapping near the top of its banks. Then a water duct was plugged by falling trees. . . .

"It was like a literal wall of water," says one witness of the resulting flood. "Apapane Street became a giant river. The walls of three homes were completely torn away. Cars were thrown against light poles, one car went right through the wall of a home. . . ."

Seventh-day Adventists heard about the disaster early, and they wasted no time in giving aid to those in the 65 homes inundated by the swirling flood waters.

"Sunday morning, after the flood had occurred on Sabbath evening, some 50 Adventists started cleaning out debris and filth from the homes," says Elder Robert Grady, lay activities director of the Hawaiian Mission who co-ordinated the aid work.

Although the Red Cross, civic, and governmental organizations also began giving aid, Seventh-day Adventists assumed the leadership role in the disaster. Quickly realizing that current stockpiles of supplies, especially bed clothing and furniture, were inadequate to meet the need, the church, utilizing its good relationships with the press, made public appeals for additional supplies.

"When the word got out to the public

via the press, we had an immediate, almost overwhelming response," says Elder Grady. "The Kaneohe World Council of Churches Women's Auxiliary president brought clothes to the disaster center we had set up on the street in which the main flooding occurred.

"The Catholic sisters asked how they could help. Joey Glanstien, eighth-grade president of the Kalaheo Hillside Junior High School, called, asking if we would

## Disaster Fund Is Established

Throughout the Pacific Union Conference in recent days, torrential rains have caused much flooding, with resulting loss of life and uncounted losses in property damage.

Among the thousands who have suffered losses there are a number of Seventh-day Adventist families. Some of our members have suffered extreme losses.

After studying the tragic reports of these flood damages, an executive action was taken to invite every Seventh-day Adventist in the Pacific Union Conference to contribute toward a fund which will be immediately used to help families who have been hardest hit by the floods and devastation.

distribute canned goods if his school collected them. The Girl Scouts called with a similar request.

"The electric company called to ask us to get the names of all affected families to them, as they planned to withhold electric bills in an effort to help out," Elder Grady writes. "Sears, Roebuck and Company offered to repair all their appliances purchased in the last few years by the families affected. They also gave bed frames, blankets, and pillows from their stores.

"Many other business houses gave valuable supplies—Wigwam Stores, C. S. Wo and Sons Co., Sealy Mattress Company, Theo. Davies Company, Kress, and Woolworth. . . . Individuals began to send

## LARGEST INGATHERING IN UNION HISTORY IS NOTED

Final reports from the Treasury Department reveal that the Pacific Union Conference has accumulated its largest Ingathering total in history. The final figure for 1968 is \$1,078,910.99, which exceeds last year's total of \$1,042,848.50 by over \$36,000. The local conferences have made the following totals:

This is the first time that a conference in the West has exceeded \$300,000. Congratulations to Southern California and its members! Hawaii has achieved a splendid gain and is first in per capita, with an average of \$21.40 per member. Nevada-Utah is second, with \$19.20. Arizona, Central California, Northern California, and Southeastern California have all registered excellent gains.

Loyal workers all along the line have done yeoman service to sustain an expanding work. Hong Kong flu, rain, and snow have all tested the metal of these workers, but we have succeeded. We bow our hearts in humble thanksgiving that these funds are available to be channeled into areas of need. Hearty appreciation to each loyal worker for his faithful service.

money . . . a check for \$50, another for \$25, other contributions of lesser amounts. . . . It was a real outpouring of community good will."

As the supplies came in, the church members continued their work in the mud-soaked homes. With the supplies given went a Bible to each family. Inside the Bible was a card inscribed: "Many waters cannot quench love, neither can the floods drown it." Song of Solomon 8:7. From your friends the Seventh-day Adventists."

"Thank God there are people like you Seventh-day Adventists," said one lady, her eyes filled with tears. "How could anybody, not knowing us, do so much for us?"

"I would like to express my deep appreciation for the emergency action taken by those of the Hawaiian Mission of Seventh-day Adventists in assisting the people at Keapuka at the time of the flood . . ." wrote Frank F. Fasi, mayor of the city and county of Honolulu.

Now the flood waters have gone from Apapane Street, and the mud has been cleaned from the homes. But the people of that place and the Seventh-day Adventists have come closer together than ever before. And although it began suddenly with a disastrous flood, it many not end there.

"A series of evangelistic meetings is being planned now by Elder Ronald Spear in the Kaneohe Church," notes Elder Grady. "Mrs. Cleo Streiffing, the Bible worker for Castle Memorial Hospital, plans to visit every flood-damaged home again to begin Bible studies and to invite them to the evangelistic meetings.

"It is true that 'God works in a mysterious way His wonders to perform.'"

Early Sabbath morning, January 25, a great wall of mud and water which had broken loose from the Twin Forks Creek beds came down in torrents upon the unprotected homes of Lytle Creek just northwest of San Bernardino. The Readmans' two-story home was filled with mud, water, and rocks. Their two cars and truck were completely buried.

Mr. and Mrs. Readman were baptized at the Azure Hills Church almost a year ago as the result of Bible studies given to them by Mr. and Mrs. W. H. Waugh, members of the Azure Hills Church.

The Azure Hills Church family, with the help of Mrs. Ida Lee, Dorcas leader; Mr. and Mrs. W. H. Waugh, and Tressie Busching, Bible worker, have rallied to help the Readman family in their time of need. Almost within one week, the Readmans were in their new home. All the furniture, bedding, dishes, and clothing have been given by the church family and relatives.

The Lord has drawn very near to the Readmans in their time of need, and, in turn, the church family has once again learned the valuable lesson that the key to living is serving and giving to those in need.

At the age of six, he increased it to \$84.03. At seven he almost doubled his previous record and solicited \$152.35. When eight years old his record was \$182.50. In 1968, when he was nine, he raised \$257.10 to make a total of \$694.23.

It is a wonderful record for a boy of nine. May his experience help other boys and girls, also older ones, to raise money for the Lord's work.

## Letters Should Be Written in Anti-smoking Campaigns

"Ladies and Gentlemen: The war against smoking is now in its most critical phase. The next few months can and will make the difference between a substantial victory and a catastrophic defeat." These were the words of Attorney John L. Banzhaf III, Director of A.S.H. (Action on Smoking and Health), as he addressed a crowd of nearly 1,000 individuals at a Stop Smoking Rally at the White Memorial Church on February 15.

The Ministers' Chorus of Southern California Conference added to the inspiration of the rally. In an interview, Elder Erling Calkins, pastor of the Santa Barbara Church, presented two individuals who had attended a Five-Day Stop Smoking program of 152 people who had stopped the habit. The two persons being interviewed had also joined the church. A unique ending to the interview was that they also have since married. That certainly is a very good outcome from a Five-Day Stop Smoking program.

Dr. Wyman Spence, of Salt Lake City, Utah, was also interviewed in which he told of several efforts he is making to help educate Americans to the hazards of smoking. He has produced the "lung" ash tray, buttons with various slogans against smoking, plaques for doctors' offices stating their stand on smoking, and a new and unusual mechanical smoker in which an individual can see the tars forming from an individual cigarette in a small plastic container. These items are available at the Conference Temperance Department.

Attorney Banzhaf pointed out that the Federal Communications Commission has given anti-smoking interests \$50 - 75 million worth of free advertising by ruling that the radio and television stations had to give one free anti-smoking commercial

and permitting four extra minutes every week of anti-smoking messages. These four minutes of commercials are worth about \$120,000.

About three weeks ago, the FCC announced that they would ban *all cigarette advertising on radio and television*. This is being challenged in the courts and this is where your help is especially needed.

In 1965, the cigarette labeling Act was very weak. It was written by the tobacco

interests and was a major victory for them. Congress must act this year. If they reenact that provision, they will stop the FCC from taking off all the cigarette ads from the air and perhaps even from giving us free time for anti-smoking commercials. If Congress is persuaded by enough people writing and voicing their objections, they may finally take effective and forceful action in the problem of smoking.

for every three commercials for smoking. Mr. Banzhaf told of challenging the largest television station in the country. In May he asked the FCC to revoke the license of WNBC-TV in New York, the flagship station of the NBC network. The next month, NBC announced they were taking four of their regularly scheduled network programs starting in the fall and cutting them short by one minute each

Tell each of them, on your private letterhead or plain stationery, not mentioning that you are a Seventh-day Adventist, that, 1) You want cigarette ads off the air. 2) That you want an effective health warning in every advertisement.

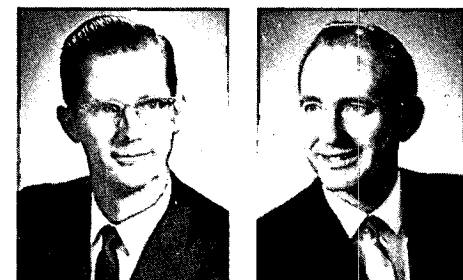

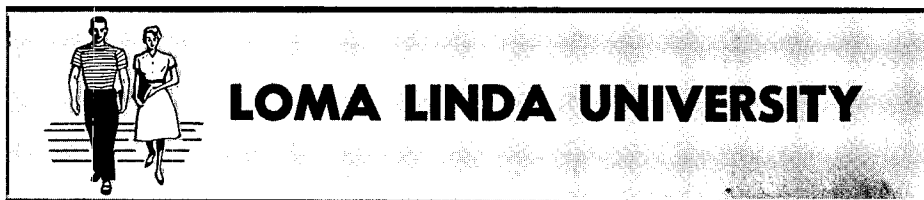

One of the world's best-known religious figures, Dr. W. A. Visser 't Hooft, former general secretary of the World Council of Churches, recently visited the Pacific Union Conference headquarters in Glendale. The distinguished churchman was accompanied by John H. Weidner of Pasadena, at whose home he was a guest during a recent visit to Southern California. During World War II Mr. Weidner, a Seventh-day Adventist, carried messages for Dr. 't Hooft and the World Council of Churches from the organization's headquarters in Switzerland into and out of occupied countries of Europe via an underground organization Mr. Weidner headed. Dr. 't Hooft's friendship toward this Seventh-day Adventist layman is evidenced in a foreword he wrote to the book "Flee the Captor" (Southern Publishing Association) which tells of Weidner's underground activities.
