Resolution No. 2—WHEREAS, It is generally recognized that there is need of some means whereby continuous instruction may be given to our church officers, and WHEREAS, The "Church Officers Gazette" has been brought into existence to supply this need, therefore RESCLYED, That each conference in our Union lay plans that will result in this paper being placed in the hands of every church officer in its territory. APRIL 8

The third meeting of the Southwestern Union Conference convened at 2:30 p.m. Hymn No. 179, "Hymns and Tunes," was used to open the meeting, and Prof. H. S. Prener led in prayer.

The minutes of the previous meeting were read and approved. It was moved and supported that the resolutions which were left over from the previous meeting

were left over from the previous meeting be tabled. This motion passed.

The chairman then called for reports.
Elder John Isaac, president of the Oklahoma Conference, reported the progress of the work in that field. His report

ress of the work in that field. His report showed a gain in tithe, over the previous biennial period, and substantial growth in all departments of the work. Elder W. E. Baxter, president of the Arkansas Conference, rendered his biennial report, which showed a substantial increase in all lines of the work, including tithes, and that the Tract Society of the Arkansas Conference is now free from debt and has a present worth.

The New Mexico Conference president, Elder V. B. Watts, reported the work in his field for the past two years. There his field for the past two years. There were many encouraging features in his report, and it showed a gain in tithe. He emphasized the importance of the General Conference, the North American Division Conference and the Southwestern Union Conference uniting with the South Texas and the New Mexico Conferences in establishing a school near El Paso, Texas, to train workers for the Mexican field.

Elder J. I. Taylor, president of the North Texas Conference, reported the progress of the work for the past two years in his field. He stated that the North Texas Tract Society had paid over to the North Texas Conference, \$1,000 per year for the past two years, of their profits. He also showed the work of the Conference to be in a good condition, except that the number of laborers on the pay-roll at the present time called for more salary than the present income of tithe.

Elder C. J. Buhalts, president of the West Texas Conference, rendered a report of his field, and stated that notwith-

West Texas Conference, rendered a report of his field, and stated that not withstanding the severe drougth that has prevailed in this field since the Conference was organized, all departments of the work have grown, and that the laborers are all of good courage.

The progress of the work in the South Texas Conference, for the biennial period, was reported by its president, Elder J. A. Leland. The report showed a substantial gain in all lines of the work, but that only a small number have been added to the church. He emphasized the importance of making a greater effort in the line of spiritual work, that larger numbers may be brought into the fold. The reports of the six presidents were discussed, and many questions were

discussed, and many questions were asked and answered, and the meeting full of interest. The meeting adjourned to meet at 10:00 a.m., April 9.

APRIL 9

For the purpose of encouraging young men to study for the gospel ministry, and in order that our evangelical work may be strengthened,

WE RECOMMEND. 1. That our con-

WE RECOMMEND, 1. That our conferences and schools urge young men, who are looking toward the ministry, to finish either a ministerial or literary course in one of our denominational schools.

2. That our conferences, in licensing young men to the ministry, require at least the completion of an academic

course of twelve grades in one of our

schools, or its equivalent.
3. That young men, who are now licensed ministers and who have not comlicensed ministers and who have not completed the academic course, be urged to pursue studies in our training schools, or in the Fireside Correspondence School, with a view to reaching this educational standard before ordination.

4. That we encourage all our workers to pursue the reading course for workers, as recommended by the North American Division Conference.

Resolution No. 6 was adopted as follows:

Resolution No. 6 was adopted as follows:

WHEREAS, The tremendous responsibility resting upon our people, the laity as well as the ministry, to give the last warning message against the worship of the beast, his image and mark and,
WHEREAS, This warning pre-eminently requires an intelligent understanding of the fundamental principles of religious liberty, all or which are to be violated by the beast and his image in enforcement of the mark, etc.,
THEREFORE BE IT RESOLVED, That it is the sense of this conference that provision be made for religious liberty instruction as far as possible in all our churches as well as at our campmeetings, in which simple, practical lessons may be given to the rank and file of our people, upon the Protestant, American, and Christian principles of religious liberty.

APRIL 9

The fifth meeting of the Southwest-ern Union Conference convened at 2:30 p.m., April 9. After singing a hymn, Elder E. L. Neff led in prayer. Resolutions No. 4 and 5 were adopted

as follows:

No. 4—WHEREAS, The last week in May has been set apart by the North American Division Conference Committee as "Self Denial Week," when all our as "Self Denial Week," when all our laborers are requested to give one week's wages for the relief of our institutions.

WHEREAS, We believe the time

WHEREAS, We believe the time has come when this terrible reproach of debt should be rolled away, therefore, WE RECOMMEND, That every laborer in the Southwestern Union Conference, cheerfully join in the pian, and further, that we encourage the laity to unite with us in giving, in money or pledges, the value of their time the last week of May, 1914, to apply on the indebtedness on our institutions.

No. 5.—WHEREAS, We recognize that there is a growing need of more efficient

No. 5.—WHEREAS, We recognize that there is a growing need of more efficient workers in our conferences and institutions in the large cities of this country, and in the mission fields, especially for well-trained ministers, teachers, Bible workers and well-trained ministers, teachers, Bible workers, and, WHEREAS, Our training schools have been established and are being maintain-

been established and are being maintained at a large expense for the purpose of giving our young people thorough preparation for the Master's service, and, WHEREAS, There are now a large number of young men and women, who are not in school, who should attend our colleges and academies to obtain a better education for the work, to the end that the message may be hastened among all classes in all lands at home and abroad, WE RECOMMEND, That an organized

WE RECOMMEND, That an organized effort be made to arouse our people generally to the value of advanced education in qualifying our young people to fill their place and part in the finishing of the work. And to this end,

WE RECOMMEND (1) That our lead-

WE RECOMMEND (1) That our leading brethren prepare articles for the "Review and Herald," setting forth the direct relation which a better preparation of our young people for service sustains to the advancement of the advent movement. (2) That in our large public gatherings and churches an effort be made to turn the hearts of parents more fully to the importance of giving their children the education necessary to efficient missionary service. (3) That two Sabbaths each year be set apart as two Sabbaths each year be set apart as

educational days in our churches, for the purpose of studying the principles of Christian education and the needs of our work, and that suitable matter be prepared by the Educational Department for that purpose. (4) That the sacred calling of the gospel ministry be kept continuously before our people, with the purpose of attracting many more bright, consecrated young men to this calling, and of inspiring them to make an educational preparation that will fit them to present the truth among all classes. (5) That a plan of tuition scholarships of fifty dollars each be arranged which shall provide for the tuition of acceptable young people in our colleges, who have finished at least twelve grades in one of our schools, and who wish to take further training for either the ministry, teaching, or other definite lines of gospel work, and that these scholarships be provided in the three following ways: (a) That each of our conferences be recommended to provide two or more permanent tuition scholarships. (b) That our larger publishing houses be encouraged to provide three or more permanent tuition scholarships in educational institutions in their respective territories, available to students who have earned two tuition scholarships in our advanced schools, either by payment annually of the sum of fifty dollars for each scholarship or by the gift of one thousand dollars as a permanent fund whose interest will provide one scholarship annually.

The Treasurer's report was read, and the delegation called for a more detailed report of local funds.

L. N. Carter, treasurer of the Keene Academy, rendered a financial report of the institution, which was accepted.

A. F. Harrison reported the progress of the book work in the Southwestern Union Conference for the biennial period. His report showed a substantial growth in this branch of the work.

Resolutions No. 7-15, inclusive were read, and the meeting adjourned.

(D) That we secure an organist for our meetings, the organist during the day to engage in missionary work.

CONSTITUTION AND BY LAWS OF SOUTHWESTERN UNION CON-FERENCE OF SEVENTH. DAY ADVENTISTS

(As adopted April 10; 1914, at Keene, Texas.)

ARTICLE I—NAME
This organization shall be known as
the Southwestern Union Conference of
Seventh-day Adventists.

ARTICLE II—OBJECT
The object of this Conference is to teach the everlasting gospel of our Lord and Savior, Jesus Christ, and to make converts to the Third Angel's Message in the territory over which it has jurisdiction diction.

ARTICLE III—TERRITORY
The territory over which this Conference has jurisdiction empaces the states of Texas, Arkansas, Oklahoma, and New

ARTICLE IV—MEMBERSHIP
Sec. 1. The membership of this Conference shall consist of:

(a) Such local conferences as have

(a) Such local conferences as have been, or shall be, properly organized and accepted by vote.
(b) Such mission territory as may be assigned to it by the North American Division Conference.
Sec. 2. The voters of this conference shall be designated as follows:
(a) Delegates at large.
(b) Regular delegates.
Sec. 3. Delegates at large shall be:

(b) Regular delegates.
Sec. 3. Delegates at large shall be:
(a) The executive committee of the Southwestern Union Conference of Seventh-day Adventists.
(b) Such representatives of the North American Division and General Conferences as may be present at any meeting.
Sec. 4. Regular delegates shall be such

persons as are duly accredited by local conferences and missions within its ter-

ritory. Sec. 5. Each local conference or missec. b. Learn local conference or mission shall be entitled to one delegate, without regard to numbers, and an additional delegate for each one hundred of its church membership.

ARTICLE V .-- OFFICERS AND THEIR

ARTICLE V.—OFFICERS AND THEIR DUTIES

Sec. 1. The regular officers of this Conference shall be a President, a Secretary, a Treasurer, and an Auditor, who shall be elected by the Conference.

Sec. 2. President: The President shall act as chairman of the executive committee and labor in the general interests of

tee, and labor in the general interests of the Conference, as the executive commit-

the Conference, as the executive commit-tee may advise.

Sec. 3. Secretary: It shall be the du-ty of the Secretary to keep the minutes of the Conference sessions, and of the meetings of the executive committee, and to collect such data from the local con-ferences and missions as may be desired by the Conference or by the executive committee, and to perform such other duties as usually pertain to such office. Sec. 4. Treasurer: It shall be the du-

ty of the Treasurer to receive all funds. and disburse them by order of the President, and to render such financial state-

dent, and to render such financial statements at regular intervals as may be desired by the Conference, or by the executive committee.

Sec. 5 Election of Officers: All officers of the Conference and members of the executive committee, except such members as are presidents of local conferences and mission fields shall be observed. pers as are presidents of local conferences and mission fields, shall be chosen by the delegates at the regular biennial session of the Southwestern Union Conference, and shall hold their offices for the period of two years, or until their successors are elected and appear to enter upon their duties.

ARTICLE VI.—EXECUTIVE COM-

ARTICLE VI.—EXECUTIVE COMMITTEE

Sec. 1. During the intervals between sessions of the Conference, the Executive Committee shall have full administrative power, with authority to grant and withdraw credentials and licenses, and to fill for the current term any vacancies that may occur in its offices, boards, committees, or agents—by death, resignation, or otherwise—except in cases where other provision for filling such vacancies shall be made by vote of the Conference. The withdrawal of credentials or filling of vacancies on the executive committee shall require the consent of two-thirds of the members of the executive Committee.

Sec. 2. The Executive Committee shall consist of the President, Secretary, Treasurer, the presidents of local conferences and missions and the secretaries in charge of duly organized departments, viz: the Publishing, Medical, Educational, Young People's Missiomary Volunteer, Home Missionary, and Religious Liberty.

ARTICLE VII-INCORPORATIONS,

ARTICLE VII—INCORPORATIONS, DEPARTMENTS, AND AGENTS
Sec. 1. Such corporations may be authorized and departments created as the development of the work requires.
Sec. 2. At each regular session of this Conference the delegates shall elect the trustees of all corporate bodies connected with this organization as may be provided in the statutory law governing each. Sec. 3. The Conference shall employ such committees, secretaries, treasurers, agents, ministers, missionaries, and other persons, and shall make such distribution of its laborers as may be necessary to execute its work effectively.
Sec. 4. The Conference shall grant credentials and licenses to its ministers and missionaries.

ARTICLE VIII-SESSIONS

Sec. 1. This Conference shall hold biennial sessions at such date and place as the executive committee shall designate by a notice published in the SOUTH-WESTERN UNION RECORD and "Review and Herald," at least six weeks before the date set for the session. Sec. 2. The executive committee may call special sessions at such time and place as it deems proper, by a like notice, and the transactions of such special session shall have the same force as those of the regular sessions.

ARTICLE IX—BY-LAWS
The voters of this Conference may enact by-laws and amenc or repeal them at any session thereof, and such by-laws may embrace any provision not inconsistent with this constitution.

ARTICLE X—AMENDMENTS
This constitution or its by-laws may be amended by a two-thirds vote of the voters present at any session, such amendments to be not inconsistent with the Constitution of the North American Division Conference, and provided, further, that if it is purposed to amend the constitution at a special session, notice of such purpose shall be given in the call for such special session.

The board, at their last meeting, voted that every cent received at this time should be used to pay interest-bearing indebtedness, and that no further debts should be made for improvements. These orders, we assure the people, will be carried out to the letter.

ARTICLE II-EXECUTIVE COMMITTEE Sec. 1. During the intervals between sessions of the Conference, the executive committee shall have full administrative power, with authority to grant and withdraw credentials and licenses, and to fill draw credentials and ticenses, and to fill for the current term any vacancies that may occur in its offices, boards, committees, or agents by death, resignation, or otherwise, except in cases where other provisions for filling such vacancies shall be made by vote of the Conference. Sec. 2. Any five members of the executive committee, including the president.

Sec. 2. Any five members of the executive committee, including the president, shall be empowered to transact such ex-ecutive business as is in harmony with the general plans outlined by the com-mittee, but the concurrence of all five members shall be necessary to pass any measure.

measure.

Sec. 3. Meetings of the executive committee may be called at any time or place by the president; or such meeting may be called by the secretary, upon the written request of any five members of the executive committee.

ARTICLE III—DEPARTMENTS

Sec. 1. The work of the departments of the Southwestern Union Conference shall be in charge of the secretaries elected by the executive committee, when not otherwise provided for by the Conference.

ARTICLE IV-FINANCES

ARTICLE IV—FINANCES

Sec. 1. This Conference shall receive a tithe from all its local conferences and mission fields.

Sec. 2. This Conference shall pay a tithe of its regular tithe to the North American Division Conference.

Sec. 3. The executive committee shall be authorized to call for such special dorations as may be needed to properly prosecute the work of the Conference.

Sec. 4. The Conference shall receive offerings devoted to missions, forwarding the same monthly to the North American Division Conference treasurer.

ARTICLE V-AUDITS

Sec. 1. The executive committee shall have the accounts of the Conference audited at least once each calendar year and shall report the same to the executive committee of the Conference at the annual meeting, and to the Conference as its regular sessions.

Sec. 2. The executive committee shall constitute a committee for auditing and settling all accounts against the Conference.

settling all accounts against the Conference, and such members as may be appointed to be present from the North American Division Conference.

Resolutions No. 1, 7, 8, 9, 11, 12, 13, 14, 15, 16, and 18 were adopted as follows: Resolution No. 1—While we regret that more has not been accomplished the past more has not been accomplished the past two years, because of our unfaithfulness, yet we recognize that the Lord has manifestly blessed and prospered the work in the Union, as shown in the increase of membership, tithe, and offerings. We, therefore, express our deep gratitude to God for His mercies, and consecrate our all for more faithful service in the future.

Resolution No. 7—Realizing the great henefits derived from the Colporteurs' Convention just closed, and the needed strength and encouragement it has given to those who bear the burdens and

to those who bear the burdens and responsibilities of the work at the front, and that any line of work can be brought to its greatest efficiency only by a thor-ough understanding and perfect co-oper-ation of all who are connected with it,

NOTICE TO ALL CHURCH MEM-BERS IN THE SOUTHWESTERN UNION CONFERENCE

At the last meeting of the General and North American Division Conference Committees, the matter of providing some relief for our schools and institutions that are burdened with debt, was seriously considered.

It was unanimously voted to set

apart the last week in May, 1914, as "Self Denial Week," and to ask all laborers in the United States and Canada to donate to our institutions their earnings for this week. This matter was also considered at our recent Union Conference in Keene, Texas, and the following resolution was adopted:

WHEREAS, The last week in May has been set apart by the North American Division Conference as "Self Denial Week," when all of our laborers are requested to give one week's wages for the relief of our institutions, and

WHEREAS, We believe the time has come when this terrible reproach of debt should be rolled away, there-

WE RECOMMEND, That every laborer in the Southwestern Union Conference cheerfully join in this plan, and further, that we encourage the laity to unite with us in giving, in money or pledges, the value of their time, the last week in May, 1914, to apply on the indebtedness of our institutions.

This resolution passed, and almost the entire congregation at the meeting, workers and lay members, voted to give as suggested in the resolution. Perhaps you were present when the resolution was adopted, and if you were, you will remember the hearty response when the vote was taken. We sincerely hope that every church member will stand by the vote.

All money given in the Southwestern Union Conference will be applied on the indebtedness of the Keene Academy. We have the assurance of the business manager and treasurer, that not one dollar of it will be used to make improvements, but that the entire amount will be used to pay interest bearing debts.
