

#### A Word of Warning

A NUMBER of our members are receiving letters asking for the names and addresses of Seventh-day Adventists residing in their community. When question is asked as to why these names are desired, the reply is usually given by the person writing that this collecting of names and addresses is merely a hobby. It has been found, however, that as soon as these names and addresses are sent to the "hobbyist," the information is used for the purpose of mailing subversive literature to the persons whose names have been provided. This literature comes from the Shepherd's Rod Headquarters in Waco, Texas. It is labeled Seventh-day Adventist literature with nothing on the heading to indicate its /actual content, but its teachings are misleading and are

#### contrary to the views and beliefs of the Seventh-day Adventist church.

Statements made by them to the Government have not properly represented the position held by the regular body of Seventh-day Adventists, with the result that we have found it necessary to appear before government officers in order to disavow this misrcpresentation and declare our denominational position.

We would therefore take this opportunity of asking our church members everywhere to exercise the utmost care before responding to these inquiries, made only with the motive of attempting to introduce teachings that are neither scriptural nor sound. We feel sure that all our members will want to cooperate with us in this. W. G. TURNER,

Do Not Submit to a Mistake in Classification

SOME Seventh day Adventist selective service registrants have been wrongly classified; and they have submitted to it. They ought not to do so. They do not need to be belligerent about it; but no man is required to submit to a wrong classification.

This wrong classification is with reference to the claim for noncombatant service. We have endeavored to distribute information to all of our people in all of the churches, that will be helpful in making out registrants' Questionnaires and the Special Form for Conscientious Objectors. We find, however, that in some cases this information has never reached the registrant; in other cases, after it has reached him, he has ignored it; and when the time has come for him to fill out his Ouestionnaire or Special Form for conscientious objectors, he has filled them out wrongly. He has made his claim for exemption, not from combatant service, which would be in accordance with the instruction of the denomination and its historic noncombatant stand, but for exemption from non-combatant service, which puts him in a totally different classification under the draft.

As an illustration of what I mean, here is the case of a Seventh day Adventist, married, with four children, who would be entitled to classification in Class 3-A. It is not likely that he would ever be called to army service in that classification. But either through lack of information or some other cause, without meaning to do so, he has made out his claim on the Special Form for Conscientious Objectors for exemption from noncombatant service instead of exemption from combatant service.

Now it so happens that the members of selective service boards, all of whom serve voluntarily, are not always informed about their own duties and are not as acquainted with selective service regulations as they should be. It happens also that in some areas of the United States there exists a positive prejudice against the claim of conscientious objection to war, and members of selective service boards are not any more free from this than other people in these areas. Therefore, either from lack of information and acquaintance with their duties, or from prejudice, a man who claims to be a conscientious objector is sometimes handled with scant courtesy.

The selective service regulations require that in classifying conscientious objectors, all other claims for deferment shall be considered first, before any consideration is given to the claim on the grounds of conscientious objection. The language of regulation 363 of the selective service regulations is: "In the case of any registrant who claims to be a conscientious objector, the local board shall proceed in the ordinary course to classify him upon all other grounds of deferment and shall investigate and pass upon his claim

as a conscientious objector only if, after physical examination, but for such claim, he would have been placed in Class 1-A, Class 1-B, Class 1-D, or Class 1-E."

There are two classes of conscientious objectors, and sometimes selective service boards do not discriminate between them. One class is conscientious objectors opposed to combatant service only. The other class is conscientious objectors opposed to combatant and non-combatant service. Unless the registrant himself is careful in making his claim, he may not provide sufficient information for a selective service board to classify him properly. Then he is likely to be placed in class 4-E, as an absolute conscientious objector.

If selective service boards proceeded to classify conscientious objectors in accordance with instructions in the selective service regulations, they would put all men entitled to deferment on the grounds of dependency in Class 3-A, and then it is not likely they would ever be disturbed. In the case to which we have referred (a man who was fully entitled to be put in Class 3-A because of a wife and four children who are entirely dependent upon his earnings, but who claimed exemption from both combatant and non-combatant service), this man was placed in Class 4-E, and in that classification is subject to call, and will be called and sent to a conscientious objectors' camp to spend one year in work of national importance under civilian direction. If he had been rightly classified, he would not be called at all.

Men wrongly classified have five days for an appeal from their classification. This is to be lengthened to ten days. Appeal boards are connected with all selective service boards, through which these appeals are to be made. Even when the appeal board refuses to reclassify such a man wrongly classified, there is still an appeal to the President of the United States.

There is no reason why Seventhday Adventists should not make these appeals when they are wrongly classified. They should not submit to wrong classification, and when selective service boards make mistakes in classifying men, they should undo these mistakes and classify them properly.

We believe that mistakes of this nature are not so likely to occur if careful attention is given to following the instructions which have been sent out to help our men make out their claim for exemption from combatant service. These instructions are contained in two leaflets, which can be obtained without charge. They are called, "Filling Out the Special Form for Conscientious Objectors," and "Seventh-day Adventists and Civil Government."

These leaflets have been sent out to all the conferences in the United States. They should have been distributed to all of the churches. If they have not been placed within your reach, you can obtain them by writing to your conference headquarters. If the conference has no supply, it can obtain a supply by writing to the General Conference Commission on National Service and Medical Cadet Training, Takoma Park, Washington, D. C.

#### Be on Guard

WE ARE reminded very often that we are drawing near the end. Material which is placed in our hands emphasizes this fact. The people of God will need to be constantly on their guard so that they will not be misled or deceived by the artful planning of the enemy of all mankind. Men will come to us, material will be sent to us, purporting to come from God. It is the people of God that Satan is working so hard to deceive. The Bible says, if possible he will deceive the very elect.

God has laid down a plan whereby any one who has received new light may make it known to the proper authorities and then that light, if accepted by the leading brethren, will be given to the membership. If the person who has received additional light has been given an opportunity to go before the brethren of the General Conference, and the General Conference brethren see no light in accepting the message, then if that person is being led by the Lord he will be willing to comply with the counsel of the servants of the Lord. God has never led anyone to try to tear down His work. God has led this people through all these years. "Enfeebled and defective as it may appear, the church is the one object upon which God bestows in a special sense His supreme regard." "Acts of the Apostles," p. 12. So, when an individual begins to question and to insinuate doubt and distrust, we know immediately where this spirit comes from.

God is not the accuser of the brethren, but the source of all evil is the accuser of the brethren. God endeavors to build up confidence and trust while the work of Satan is to tear down. On pages 294 and 295 of Volume VIII, we read: "I say to all, Be on your guard; for as an angel of light Satan is walking in every assembly of Christian workers, and in every church, trying to win the members to his side. I am bidden to give the people of God the warning, 'Be not deceived; God is not mocked.' ... I have been instructed that it is

not new and fanciful doctrines which the people need. They do not need human suppositions. They need the testimony of men who know and practice the truth, men who understand and obey the charge given to Timothy: 'Preach the word; be instant in season, out of season; reprove, rebuke, exhort with all longsuffering and doctrine.' . . . Walk firmly, decidedly, your feet shod with the preparation of the gospel of peace. You may be sure that pure and undefiled religion is not a sensational religion. God has not laid upon any one the burden of encouraging an appetite for speculative doctrines and theories."

"In order to sustain erroneous doctrines or unchristian practices, some will seize upon passages of Scripture separated from the context, perhaps quoting half of a single verse as proving their point, when the remaining portion would show the meaning to be quite the opposite. With the cunning of the serpent, they entrench themselves behind disconnected utterances construed to suit their carnal desires. Thus do many wilfully pervert the word of God. Others, who have an active imagination, seize upon the figures and symbols of Holy Writ, interpret them to suit their fancy, with little regard to the testimony of Scripture as its own interpreter, and then they present their vagaries as the teachings of the Bible." "Great Controversy," page 521.

It is indeed strange that lany one would use the Spirit of prophecy to try to prove their points and to win individuals to their way of thinking and yet utterly disregard other teachings in the Spirit of prophecy which have to do with the teaching of new light. God has told us through His servant that if any new light is received, it should be taken to our General Conference brethren and if they see no light in accepting it, then we as a people should reject it. God has never placed the responsibility upon any individual in His organization to be the accuser of the brethren.

Let us bear in mind in our spiritual lives that Satan is dressed in Sheep's clothing. We need to beware lest we be led astray from the narrow path that leads to life everlasting. Dear people, we need to study our Bibles and the Spirit of prophecy more and more as we draw nearer the end. If we do not have our feet firmly established upon the true foundation, Satan will, without doubt, deceive us and lead us to destruction. But the power of God is sufficient to guide us from day to day if we sincerely ask heaven for it. May God keep us true to His message until the V. A. LAGRONE. end.
