Report of work of city missions called for. Bro. Sakhy rura rted that books were furnished the Washington mission, and the workers sold these books to pay running extenses. During the

winter, or until Jan.1st. canvessing is made the most prominent work, and during the other partnof the year the Bible reading work is made the principle effort. Mission expenses have run from 750.00 to \$1000.00 per year. This includes everything, except wages of laborers, even the furnishings of Mission and Hall. The management of the mission has had no instruction as to whether it is desirable for the workers to pay their own board or not. The opinion, however, is entertained that it is more advantageous for the workers not to pay their board, because in that case they would sell more books. Bro. Saxby is of the opinion that it is better for most of the workers to go north during the summer months, and have a larger forse in winter.

Bro. Raymond spoke of the Philadelphia mission. Bro.Kutz, he says, rents the house, and pays his own rent and house expenses, and the Conference pays him by the week for his work. He holds readings. Each warker pays his own board and is paid wages weekly wages by the Conference. Bro. Butz is made responsible for all the books that pass through his hands for the workers. The present method, it is thought, has greatly reduced the mission expenses. There is, as in Washington, a growing interest

The Pittsburgamission is conducted on the same plan, as at Philadelphis.

The Williamsport mission is run on the same principle as Washington, but the brethren think it would be better if it were on the same basis as the Philadelphia Mission.

Bro. Lindsay said that inBestomore he and Brother Lewis, of

the canvassing Co., rent the house occupied. Lewis is responsible for all books, and also for the rent. The actual cost for each worker, rent and board, is \$1.65 per week, and if they can have four or five Bible workers to follow the canvassers, they could get a better place in a more eligable part of the city fully as low per member. He thinks that by all means there should be such workers there, as there is no Bible work being done in the city. The work now done, is all canvassing.

Bro. Robinson says that, strictly speaking, N.E. has no city missions, though they have several canvassing stations. In brook-lyn they pay the rent, and charge Bro. King \$10.00 per month, and he runs the house; but he charges the worker's \$2.00 per week for their board. The work is in good working condition,--goodd working order.

Concerning the Sprongfield Mission, the mission workers may the rent, and their board. They have seven companies working on this plan, and it works well. Bible workers follow the canvassers and the Conference simply pays their wages, and they pay their own board. The head, canvasser is made responsible for all books used.

Dear Brethren; --

I desire to invite your attention to some matters of interest in the New England Conference, and especially relating to South Lancaster Acedemy. We have every reason to fear that unless we are able to take some steps to prevent it, we shall soon reach a financial crises which will be disastrous to the institution.

When the school was first started, and during the first few years of its existence, a large amount of money was berrowed of our brethren, much of which was at a low rate of interest, and some without interest. short time.

Of course, the money raised for shares, when the sch of first started, and much of the money borrowed, was invested in the land purchased and in the school buildings which were erected at that time. The principle part of the moey received from the lowe estate, two years ago, was used up in the Erection of additional buildings.

On examination of the books it appears that the liabilities of the Acedemy exceed the total resourses, by some \$5000. Of tourse, quite a large amount of this indebtedness is money loan d which it is hoped will never be called far out. But during the past year, a good many who had small amounts on deposit have been obliged to call for their money. The Academy thus far has been able to meet all thedemands made upon it, but in view of the fact that the school does not meet running expenses, and there is a mortgage on the property of \$5000 which comes due next fall, we urgently request the Gen. Conf. Com. to take this matter into consideration and recommend to the management of the Acedemy, as to that policy to pursue. The board of trustees have thought it next to lay these facts before you, and it is at their suggestion that I do so.

As to other branches of our work, there are many encouraging features. Three new churches and two companies have been organized within the past year. We have several young men in the field who give promise of becoming successful laborers. What we greatly need is to have one minister of experience, who could labor and visit in connection with our different tent companies, and help them in that critical period of the meeting when the people are brought to the point of taking their stand. We feel certain that great vistories were lost right on this point last year, where there had been a remarkable interest; but somehow, when the people were brought to a test there seemed to be a failure to get the proper ones to take hold, and the result would be that the interest would sort of die out.

The amount of tithes paid have inreased considerably and we would be able to support such a minister, and we would feel very grateful to the gen. Conf. if they would send ald. Corliss to labor in our Conference during the coming spring and summer, even if he should spend only a portion of his time in the work above suggested and a portion of the ime in writing.

Our Canvassers are having very good success. The amount of orders taken during the last seven weeks has been over \$600 per week.

The Canvas sing Outlook.

The general condition of the canvassing work was never more satisfactory, or the outlook so promising as at present. During the past year we have made great advancements in this line, and the canvassing work has become more general. Last year the canvassing work was confined to but a few states, and when a drouth od calamity happened to befall those states, it almost entirely stopped the work. But, with the organization of the other states, under the supervision of atkex active general agents who have been able to give their whole time to it, a more satisfactory condition of thing has been brought about. We now have state agents in Arkansas. Alabama, Mississippi, Colorado, Dakota, Deleware, Maryland, Georgia Illinois, Indianna, Iowa, Ohio, Kansas, Louisanna, Maine, Minnesot: Michigan, Missouri. Nebraska, New England, New York, North Corolina, Ontario, Pennsylvania, Province of Quebec, Tennessee, Kentucky. Vermont, Virginnia, West Virginia, and Wiscondin. the exception, perhaps, of Maine there has been a large increase in the number of canvassers employed, and a corresponding sale of books. Great activity has been displayed in Penn. and the New . England States, which now can be ranked among the first in the Canvassing work. Kansas, Minnesota, Iowa, and Illinois have been and still are, the leading States in the canvassing line. A Week have sold morebooks this year than any other since the colvessing

work was started, and have from five to seven hundred agents now in the field selling our different denominational books, and the prospects for an extensive sale of our publications was never between. As the canvassing work has become more widespread, no crouth or short crops, affecting a particular locality, can seriously himder the sale of our books, as was the case two years ago when our canvassing work was confined mostly to a few western states

vance steps have been taken in the canvassing work the present year, and which are proving very successful.

At our last general conference, held at Minneapolis, Minne.; it was recommended that companies of canvassers should be sent into unoccupied fields, the gen. Conf. Agreeing to pay their transportation. Those companies have reached their field of labor and have commended work. They are meeting with success for beyond their most sanguine expectations. The company sent to Louisanna reports remarkable success, not only in the matter of book sales, but inninteresteing people in the truth, several of whom have already began to obey. This company consists of eight members,, and another company will be organized very soon.

The company of canvassers sent to West Virginia is doing remarkably well, and has already ordered about a thousand books since entering that field, and the reports are full of cheer, reporting

many people su interested in the truth.

The company sent to North Carolina has been equally successful and several new members have been added from that field. All are

doing better than was anticipated.

The company in Baltimore is doing as well as the others already, mentioned, and the prospects for good work in Marylandare
flattering. We may say that it is neven better in these new fields
than in the old.

We have also a company of banvassers at work in Toranto, Can., who are doing better that in the United States. The company in the province of Quebec is also fdoing well.

The Review and Herald has established a branch house at Toranto, and will print books there, so as to obviate the difficulties with which

c Canadian canvassers have to contend, in the way of duties, &c., and which will enable them to work to a n equal advantage with the canvassers in the U.S.

The canvassing work among the West India Islands is proving a great success in selling Thoughts on Daniel and the Revelation.

We have shipped to this field within the past few months some six or eight hundred copies of that book. I have no recent report from the canvassers in Australia and new Zealand, but if I am to judge by the numberoof books ordered by the Pacific Press, I should say they are doing a good business.

one point to which I wish to call the attention of this committee is concerning the remarkable success attending those companies sent into them, what we may denominate mission fields.

Where no tract society has as yet been established. The influence that the candageers carry with them has been good, and the prosepects for preparing the way for the living preacher are all that

could be desired. Truly, the experiment of sending canvassers into new fields by the den. Conf. has proved to be practical. There are other mission fields which might now be entered. There are experiended canvasseers, in different lacalities from which workers can be drafted; and I would therefore respectfully offer the following suggestion, viz.. That steps be immediately taken, or as soon as the General Conference may deem advisable, to send a company of canvassers into Manitoba and British Colombia. The success which attends the Canadian canvassers already employed, demonstrates the fact that the Northern Canadian field is a fruitful one.

The success of the work in the West India Islands, clearly shows that books can be sold in foreign lands, and I would therefore suggest that a company of canvassers be sent to that field. to canvass first one Island and then another, and follow down from the lesser to the greater Antilles. As some of the Western States have been drouth stricken for a number of years, and the canvassing work there has become very discouraging. I would recommend that the canvassers in such fields be moved toother and more prosperous localities, and that the State receiving them be request ed to pay their transportation. The canvassers to take care of the them selves after their arrival At present there are about 30 can vassers in Kansas, many of whom are unable to pay their own way. Some could be transfered into Missouri, in which case Mo. would be willing to pay their transportation. Others still might be transfered to favorable localities in the Indian Territory and wew I would ask the gen Conf. to pay the cost of their transportation, thus peeping all our canvassers well employed, and preventing their becoming discouraged in the work, and seeking employe 52

ment clse where.

The experience of the last three years has proven that if good territory can be found for our eanwassers, so they can support themselves, a large force can be kept comtinually in the field. I believe that the importance of having such a corps of workers will be more fully realized in the future than in the past, as an experience is gained in the canvassing work that no other branch can afford. I would also add that many more canvassers could be advantageously employed in Canada and different parts of the field, Mexico, and the different States of central America, who which have scarcely been entered by the canvasser, should receive you careful attention. There are plenty of English speaking people in all these countries, and this would open the way to become acquainted with the Spanish speaking people, and determine better what publications should be prepared for them.

Taking into consideration the fact that this large army of canvassers can go out and carry the message without any expence to the gen. Conf., making their own way, except for transportation (asking this only because they are too poor to pay it themselves) something should be done to transfer them to more feritle fields, and I trust that this report and these suggestions will receive the careful and favorable consideration of your committee, to the end that some plan may be devised to transfer those of our poor struggling canvassers who are trying to gain a livelyhood in baren fields, to those more fertile and productive, and that the precious seed they are going forth to sow may not all fall upon hard ground.

INTRODUCTORY REMARKS WERE MADE BY ELD. WHITE GIVING THE REASON OF OUR COMING TOGETHER; THOUGHT IT WAS A GOOD TIME TO HAVE TRESE MISSION-ARIES MEET TOGETHER AND CONSIDER THEIR FIELDS WHILE THE COMMITTEE ARE THE SO. APRICAN FIELD WAS FIRST CONSIDERED AND THE PROBABIL-ITIES AND POSSIBILITIES OF THE WORK THERE THOROUGHLY CANVASSED. LETTERS WERE MEAD FROM ELDS. HANKINS AND BOYD. THEY BOTH EXPRESSED PLEASURE AT THE PROSPECT OF HAVING BRO. AND SR. DRUILLARD WITH THEM. IT WAS THOUGHT BY THE COM. THAT SR. DRUILLARD SHOULD BE THE SEC. AND TREAS. OF THE MISSION, AS THERE IS NO CONF. OR TRACT SOCIETY ORGANIZED ELD. WHITE THOUGHT THAT IF A BOOK DEPOSITORY, CORPS OF CANVASSERS AND A SCHOOL COULD BE STARTED ON A BUSINESS BASIS, IT WILL NOT BE NECESSARY TO ESTABLISH A CITY MISSION IN CAPE TOWN. HE ALSO STATED THAT THE LONDON BRN. THOUGHT THEY COULD NOT SPARE HETTLE HURD IN ANSWER TO SR. DRUILLARD'S QUERY AS TO TO GO TO AFRICA. WHICH SHOULD GO FIRST, THE CANVASSER, OR THE BIBLE WORKER, THE CHAIR THOUGHT THE CANVASSER SHOULD PRECEDE THE LATTER IN NEW FIELDS.

SR. DRUILLARD WISHED THE MATTER OF THE SCHOOL DEFINED; HOW MUCH OF A ONE IT WOULD BE BEST TO START, AND THE NUMBER OF MONTHS IT SHOULD CONTINUE: STATED THAT SHE HAD INFORMATION THAT THERE ARE ABOUT FORTY PUPILS ALL READY TO ENTER A SCHOOL WHEN STARTED.
