66/230 PRESIDENT'S REPORT

F. C. Webster, instead of presenting a report of past accomplishments, invited the members of the committee to look to the future and to accept the challenge of evangelizing the territory of the Middle East Division in the shortest time possible. With 51,755 people in the Division territory for each church member this Division faces a task greater than that of any other Division. With full assurance that the prediction made

by Ellen G. White in Great Controversy page 611 is to be fulfilled we should go forward with renewed faith. "The work will be similar to that of the day of Pentecost. As the 'former rain' was given, in the outpouring of the Holy Spirit at the opening of the gospel, to cause the upspringing of the precious seed, so the 'latter rain' will be given at its close, for the ripening of the harvest. 'Then shall we know, if we follow on to know the Lord: His going forth is prepared as the morning; and He shall come unto us as the rain, as the latter and former rain unto the earth.'"

66/231 WORLDWIDE REVIVAL AND EVANGELISM

VOTED, That the following program for worldwide revivals and evangelism be adopted:

This program of worldwide revival and evangelism calls for total mobilization of the whole church under the power of the Spirit of God in revival, reformation, and a wave of evangelism that will sweep around the world.

I. IN-REACH -- Revival and reformation within the church of God has been clearly defined as a return to primitive godliness. This revival and reformation must involve repentance, confession, restitution, growing up in Christ, prayer, obedience and the exercise of faith in individual Christian experience in preparation for our Lord's return. This revival under the ministration of the Holy Spirit should begin first with the ministry and then reach out to church officers and members bringing with it a compelling love for souls.

Not by resolutions alone will a worldwide revival and reformation be experienced. It must become:

1. The burden of prayer and study on the Division and local Section committees.
2. The core of messages at workers' meetings, camp meetings, Division and local Section sessions, youth and lay rallies and in all denominational institutions.
3. A reality in a series of well-planned revivals in all of our churches around the world to prepare the way for the evangelistic crusades.

To this end the various departments should become the willing aid to the pastor in preparing the church and the world for this evangelistic thrust. All should be so coordinated as to strive for the achievement of our great objective.

II. OUT-REACH -- When this is implemented every Adventist pulpit should reverberate with fundamental Bible doctrine emphasizing the distinctive message of the third angel and enshrining Christ in the heart of each sermon.

No field or area should be neglected. The message must certainly be repeated and the cause greatly expanded in areas where the work of God is already established; however, let each leader, Section committee, and institutional board perfect bold plans to establish the work in unentered areas. Such efforts should continue until strong churches and institutions have been erected to the glory of God. The time for an unprecedented world-wide advance is here. A larger soul-winning work must be accomplished in the great cities of the world. Let us unitedly move forward with God. "If Christians were to act in concert, moving forward as one under the direction of one power for the accomplishment of one purpose, they would move the world." --Christian Service, p. 75.

Let every church, every Section and the Division launch out by faith in setting baptismal objectives within the framework of fervent prayer and unwavering faith in the limitless power of the Holy Spirit. Let the chief burden of administrative officers, departmental secretaries, pastors, church officers and church members be focused on the winning of souls. We encourage our administrators and departmental secretaries to participate with our pastors in public evangelism. We encourage our local church officers to more fully fulfill the duties of their offices as clearly called for by the Spirit of Prophecy and as outlined in the Church Manual, thus freeing the pastors for soul-winning work.

Let baptismal days be set each quarter in every church, reports of unique experiences and encouragement be reported in the Middle East Messenger, the Ministry Magazine and the Review and Herald.

In order to obtain these baptismal objectives, let each department assume as a minimum goal the following responsibilities:

1. The Publishing Department plan to have at least one resident literature evangelist in each church.
2. The Sabbath School Department continue and expand its efforts to train teachers to assist the pastor and local church elders in shepherding members, locating missing members, and organizing branch Sabbath schools and vacation Bible schools.
3. The Lay Activities Department earnestly give increased impetus to Bible studies and systematic literature distribution on an unprecedented scale, organizing members for concerted efforts such as the Gift Bible Evangelism program. Dorcas welfare groups should share faith as well as clothes and food.
4. The Public Relations Department through public information, personal contact and participation, shall strive to prevent misunderstanding, and help in developing a climate of informed favorable opinion toward the Seventh-day Adventist Church, its work and its distinctive truths.
5. The Department of Public Affairs and Religious Liberty shall continue to discreetly meet and follow up each religious liberty crisis with definite evangelistic objectives.

6. The Radio and Television Department shall offer an increasing coverage of the message. Through the Voice of Prophecy, Faith for Today, and It Is Written programs, and by increasing local broadcasts and telecasts by pastors and evangelists, the Advent message in all of its beauty shall be presented to the multitudes. Correspondence courses shall be improved and updated and Faith for Today and Voice of Prophecy evangelistic teams invited to enter areas for evangelistic reaping campaigns.

7. The Department of Education shall continue to encourage and foster a deeply religious atmosphere in each classroom, confronting each student with his relationship to the Saviour and His task.

8. The Medical Department shall constantly uphold the soul-winning objectives before all medical institutional personnel and lay tactful plans for arousing interest and follow up work. Dedicated physicians and dentists should be encouraged to locate in unentered areas for the purpose of using their influence in witnessing for Christ and thus open the way for the message to enter.

9. The Temperance Department shall strive to enlarge the work of helping people break the chains of defiling habits and thus prepare hearts for the reception of the third angel's message.

10. The Missionary Volunteer Department shall continue to organize youth to actively involve themselves in evangelistic campaigns and church projects; fulfilling the promise, "With such an army of workers as our youth, rightly trained, might furnish, how soon the message of a crucified, risen, and soon-coming Saviour might be carried to the whole world." -- Education p. 271.

11. Distinctive Bible truths that make us a people shall be featured by our missionary journals, division and union papers, and by the Review and Herald. Ambitious circulation goals for missionary journals shall be set using division, union, and official church organs to inspire progress in this worldwide program.

12. The Ministerial Association, by precept and example, shall continue to cooperate with administrators at all levels in encouraging each minister in year around evangelism, especially seeking to help the less productive workers.

13. A stronger follow-up program shall be initiated to make the greatest use of Bible school enrollees and interests stirred through this expanded program of evangelism.

In carrying out the above 13 points church pastors will be able to see in each denominational department here listed an invaluable assistant.

IMPLEMENTATION -- WE APPEAL TO THE COMMITTEES OF EACH LOCAL SECTION AND TO THE BOARDS OF EVERY DENOMINATIONAL INSTITUTION, TO LAY

BROAD AND COMPREHENSIVE PLANS FOR THE IMPLEMENTATION OF THIS PROGRAM OF  
EVANGELISM IN THEIR RESPECTIVE AREAS BY JANUARY, 1967.

All organizations are requested to report the plans developed and make periodic progress reports to the next higher organization. Such reports, as they are passed on to the General Conference president, will be shared with the officers and departmental secretaries of the General Conference, and will form the basis of comprehensive reports to the world field for its encouragement and inspiration.

66/236 SPIRIT OF PROPHECY EMPHASIS

WHEREAS, There comes from the 1966 Autumn Council to all our churches throughout the world an imperative call to revival and reformation and an unprecedented breakthrough in evangelistic efforts, and

WHEREAS, God, in His providence, has graciously imparted to the church through His messenger powerful messages calculated to lead God's people into an experience of holy living and reception of the latter rain, and

WHEREAS, The Spirit of Prophecy volumes abound in counsels leading to successful living and evangelistic endeavors in all areas of service,

VOTED, 1. That in these crucial times a message go to all our members calling for a renewed and prayerful study and application of the Spirit of Prophecy counsels which were given for our encouragement, correction and guidance in personal life and missionary activity.

2. That all our people be urged to secure for their library all lacking Spirit of Prophecy volumes and also use them as gifts for friends. To this end we call attention to the opportunity to secure Spirit of Prophecy books at the liberal subsidy allowed.

66/237 SABBATH SCHOOL OBJECTIVES

WHEREAS, World conditions indicate that we have come to an hour of unprecedented opportunity, and

WHEREAS, It is being demonstrated in many fields that the Sabbath School can be, as the pen of inspiration has indicated, "one of the greatest instrumentalities, and the most effectual, in bringing souls to Christ," therefore

VOTED, 1. That we give renewed emphasis to personal Bible study, calling upon our members throughout the Division to greater faithfulness in the daily study of the Sabbath school lesson.

2. That our Sabbath school officers, teachers, and members enter upon a special effort in cooperation with pastors and church officers in winning missing church members to faithful Sabbath attendance through a regular program of systematic personal visitation.

3. That we continue to promote a strong every-member program of evangelism of inviting neighbors and friends to attend Sabbath school.

4. That every effort be made by Section Sabbath School Secretaries to arrange for teacher training courses to be taught by pastors or other qualified persons in the various districts of the Division.



5. That we encourage the Sabbath school teachers to regard their classes as soul-winning bands, and that they lay plans with their classes to conduct branch Sabbath schools and to carry on an organized visitation program in their communities.

6. That members throughout the Division be urged to greater personal soul-winning efforts and sacrificial giving in Sabbath school offerings.

VOTED, 1. That we aim at the ideal of at least one literature evangelist in every church, and

2. That in this day of unparalleled opportunity, Section officers, Publishing Department secretaries and literature evangelists endeavor to greatly enlarge the soul-winning potential of the publishing program in the following ways:

- a. Combine some full-message literature with every unit of sale.
- b. Secure an ever-increasing number of Bible correspondence course enrollments.
- c. Distribute a larger quantity of free literature, especially to non-buying persons.
- d. Avail themselves of every God-given opportunity to pray with people.
- e. Cooperate in organizing branch Sabbath schools in isolated or unentered places wherever possible.
- f. Work closely with pastors and evangelists and supply them with names of interested persons.
- g. Fully support well planned group canvassing campaigns to prepare cities and towns for evangelistic meetings.
- h. Personally invite and, where possible, accompany interested people to evangelistic meetings and Bible study groups.
- i. Personally participate in Bible study opportunities as frequently as possible.

## 66/251 HONORARY CREDENTIALS -- POLICY REVISION

VOTED, That paragraph 3 on page 47 of the MED Working Policy be revised to read:

"3. Honorary credentials shall be granted by the Division to sustentation beneficiaries corresponding to the Ministerial Credentials, Missionary Credentials, Bible Instructor Credentials, or Literature Evangelist Credentials they held as credentialed workers while in active

service. Workers already on the Sustentation Fund before 1966 shall continue to be granted honorary papers of the same kind they held prior to 1966!

66/252 NATIONAL WORKERS RETURNING TO HOME DIVISION

VOTED, That when a national who has gone abroad at his own expense is called to denominational service in the Middle East the following provisions shall apply:

1. The call shall be processed through the General Conference secretarial department including a request for physical examinations for the prospective worker and the members of his family.

2. That the Division shall pay for bus connections to a designated airport near the worker's location and for economy class air transportation to the field of labor on behalf of the worker and all members of his immediate family.

3. That an outfitting allowance be granted to the worker on the following basis:

a. Head of family	\$250.00
b. Each child	25.00
c. Single worker	125.00

4. That the Division shall pay surface freight shipping expenses (including packing and insurance) on a gross weight of up to 1,000 pounds for the goods of a single worker or up to 2,000 pounds for a family. In case a worker does not transport his maximum weight, he shall receive an allowance of \$20.00 or its equivalent in local currency, for each 100 pounds of unused weight privilege.

5. That the above allowances and costs except salary, as outlined in this policy, shall be considered as a prepaid expense and amortized on the basis of 20 per cent for each year of the worker's service after his return to his homeland. In the event the worker leaves denominational employment before the entire amount has been amortized, the unamortized portion shall be repaid by the individual to the employing organization.

6. That salary for such workers commence one month prior to his arrival in the Division. The employing organization will assume responsibility for the expenses from the port of entry as worker's moving expense.

7. That if the worker is called to another organization, the calling organization shall assume the unamortized portion of the above allowances and costs, except salary, and shall continue the process of amortization on the original basis.

8. A graduate study reimbursement allowance to be paid by the employing organization in annual installments of \$500.00 or its equivalent in local currency, shall be granted to workers having earned degrees as follows:

- a. For an M.A. or equivalent \$1,500.00
- b. For a B.D. or S.Ed., 2,500.00
- c. For an M.Th. 3,000.00
- d. For a Ph.D., Ed.D., or equivalent 4,000.00

9. The salary for a worker called under this policy will be based on the national wage scale for the position to which he is called.

66/254 FILIPINO WORKERS' POLICY

VOTED, 1. That calls for Filipino workers to serve in the Middle East Division shall be channeled through the General Conference with actual appointments and processing of appointees to be handled by the Far Eastern Division.

2. That the period of service for workers with families shall be five years with a nine-month furlough inclusive of travel; and for single workers, four years with a nine-month furlough. If it seems advisable because of the nature of his work, family conditions, or in consideration of the best interests of the organization, the worker who has completed 60 per cent of the regular term of service may be granted a short furlough to his home base of one third the regular furlough period inclusive of travel; it being understood that each case will be considered on its own merits by the Division committee.

3. That the outfitting allowance for Filipino workers shall be as follows:

- a. Single workers, full term of service, the equivalent of \$200.00 (U.S.)
- b. Families without dependent children, full term, the equivalent of \$400 (U.S.).
- c. Families with children, for each dependent child, the equivalent of \$60 (U.S.)

4. That freight, cartage, handling, packing, insurance, and crating charges shall be allowed as follows:

Class A families - man and wife	3,600 lbs.
Additional for each child	300 lbs.
Single workers	1,800 lbs.
Class B families - man and wife	1,800 lbs.
Additional for each child	300 lbs.
Single workers	900 lbs.

5. That in cases where appointees elect to take to the mission field less than the freight allowance provided for above, the Division shall compensate the appointee at the rate of \$20.00 per hundred pounds or its equivalent in local currency covering the unused portion of his authorized freight allowance. In case the worker is requested to travel by air, the freight allowance may be increased for each full fare ticket by 350 pounds.

6. That the salary is to be set in harmony with the local wage scale for national workers in the same category, bearing in mind that the salary to be set shall be at least the equivalent received by comparable workers in the Philippine homeland.

7. That the Filipino overseas worker shall be granted the privileges of the Exchange Policy as outlined in the General Conference Working Policy.

8. Freight and outfitting allowance shall be granted to workers returning from furlough equal to ten per cent of the regular freight allowance and of the regular outfitting allowance for each year of service during the previous term.

9. That the Filipino overseas worker shall be granted the privileges of the Exchange Policy as outlined in the General Conference Working Policy.

10. The following allowances shall be made in the case of permanent return of the worker.

a. Continuation of salary up to three months from date of departure from the field.

b. Rehabilitation allowance equal to one half of the outfitting allowance.

c. Freight allowance for man and wife 1,000 pounds, additional for each child, 100 pounds.

11. That to meet some special need, and where no language study is involved, single women missionaries may be called from the Philippines on a short-term basis for two years. In such cases the following provisions shall apply:

a. Outfitting and rehabilitation allowance (each way) \$100 (US)

b. Freight allowance going and returning (each way) 500 lbs.

c. Where a single woman who has given a short term of service is called by an overseas division to return for a regular term of service a furlough of up to three months in duration may be authorized by the committee.

66/255 WORKERS' WIVES -- EMPLOYMENT AS BIBLE WORKERS

VOTED, That in the Working Policy, page 93, paragraph 4 be added as follows:

"4. Section committees may employ the wives of workers as Bible Instructors whenever their preparation and ability would render them efficient in this work."

Edwin Gibb presented the devotional study based on the experience of Elijah recorded in 1 Kings 17. God cared for His servant as he faced Ahab and later the prophets of Baal. Often the worker is tempted to move forward only when the way is cleared of all obstacles. But this is not a demonstration of true faith. The prayer of each one should be that he recognize and take advantage of every opportunity God presents to him.

## 66/280 STUDENT LITERATURE EVANGELIST POLICY

WHEREAS, Some of the students in Middle East College and our academies would like to sell books on a part-time basis during the school year, and

WHEREAS, The General Conference Publishing Department policy, page 93 says, "Any student who can devote some time to selling books and magazines during the school year and thereby earn a scholarship should be permitted to do so," it was

VOTED, 1. That we encourage college and academy students to canvass during the school year, provided the Section Publishing Department can provide proper supervision and training for them.

2. That a student literature evangelist receive a scholarship bonus on the sales he makes during the school year, provided:

a. He sells at least LL 200 worth of literature during the school term.

b. He canvass as on the regular scholarship plan during the following summer months, working the required 400 hours (350 hours, if a lady) during the summer period.

c. He gives to the manager of the Book and Periodical House 25% of his sales made during the school year to add to his scholarship account. He may pay this sum at the end of the summer period when the manager prepares his Eligibility for Scholarship Bonus Form to send to the school.

#### 66/281 PROFESSIONAL MEMBERSHIP FEES AND JOURNAL ALLOWANCE

VOTED, To substitute the following for the policy on professional supplies as now on pp. 101 and 102 of the MED Working Policy:

"That Division and Section officers, departmental secretaries and evangelistic field workers may submit paid bills for purchases of professional books and equipment to be used in their work for which subsidy will be allowed on the following basis: The employing organization will reimburse the worker in full for the first LL 50.00 or its equivalent on such purchases and will share an additional LL 100.00 expense on such purchases with the worker, affording a total possible yearly subsidy of LL 100.00. Controlling boards of institutions are to determine which of their administrative personnel are to come under this policy. Special professional journals and membership fees for certain institutional workers may be paid by the institutions upon action of controlling boards."

#### 66/282 MEDICAL EXPENSE POLICY

VOTED, To amend the Medical Expense Policy (MED Working Policy, p. 98) paragraph 1, to read as follows:

"1. A worker having medical and/or dental and/or optical and/or hearing aid and/or obstetrical expense may be allowed 75 per cent of the expense; the allowance to be made only on receipted medical bills for which the worker has actually made payment. Assistance as provided for above may also apply on the expense of medical and orthopedic appliances when prescribed by a qualified physician."

Delete paragraph No. 2 and renumber the others.



66/283 UTILITY ALLOWANCE POLICY

VOTED, To amend paragraph 1 of the Utility Allowance Policy (MED Working Policy, p. 96) by changing LL 147.50 to LL 150.00.

66/284 WAGE SCALE

VOTED, To adopt the new General Conference Overseas Wage Scale.

66/285 RENT CEILING--LEBANON

VOTED, That the following rent ceilings be set for Lebanon:

	Married workers	Single workers
Beirut	40%	30%
Outside Beirut	30%	20%

Further, that throughout the Division the rent subsidy ceiling for single workers be 10 per cent of the wage scale below that of family heads.

66/286 MEDICAL EXPENSE--MRS. VICTORIA HADDAD

VOTED, That in view of the heavy medical expense incurred in the surgery of Mrs. Victoria Haddad, mother of Anees Haddad, special aid be granted to help with this expense following the general lines of the medical policy.

66/287 VISITATION DAY TRACTS---SUBSIDY

VOTED, To increase the annual subsidy from LL 1,500.00 to LL 2,500.00 for a special fund to provide a subsidy of 50 per cent on orders for Home Visitation Day tracts until this fund is depleted, it being understood that this will provide a subsidy for at least 100,000 tracts.

66/288 GEORGE KHOURY RESIGNATION--LEBANON SECTION

WHEREAS, Elder George Khoury has expressed personal convictions that he be appointed to evangelistic rather than administrative work, and

WHEREAS, The officers have discussed these convictions with Elder Khoury in the light of the confidence of the organization in his work, and

WHEREAS, Elder Khoury has requested an immediate change in order to provide relief from the heavy personal demands of the office on his health and well-being, it was

VOTED, To accept with regrets the resignation of George Khoury as president of the Lebanon Section and to express our appreciation for the service he has given in this position.

66/289 LEBANON SECTION ADMINISTRATION

VOTED, To appoint the Division president to care for the temporary administration of the Lebanon Section.

66/290 DIVISION COMMITTEE--ADDITIONS

VOTED, To add Chafic Srour and R. W. Wilmot to the Division committee.

66/291 SUPPORTING EVANGELISM THROUGH PUBLIC RELATIONS

WHEREAS, We recognize that, in addition to our dependence on the Holy Spirit and increasing emphasis on prayer, global evangelism will under God's leading require the use of the best tools that modern technology can provide,

VOTED, That the Bureau of Public Relations and its field representatives seek to:

1. Keep before the workers and members of the church the goal of creating a public image of Seventh-day Adventists as true believers in God and promote through all available channels this recognition of God's people.
2. Exempt Seventh-day Adventists from the prevailing prejudice by stressing that we are not associated with any parties, nations, or movements aimed at destroying Islam or dominating Islamic peoples but that our allegiance is only to God and the government under which we live and belong, and by emphasizing that Seventh-day Adventists are the friends of Muslims who share common doctrines and goals where these are meant to strengthen the spiritual values and moral life of the community, noting, for instance, that as followers of Christ we do not drink wine, smoke cigarettes, eat unclean meats, dress immodestly, follow worldly amusements, address prayers to saints, or accept other idolatrous religious practices.
3. Step up news activity that will help to mold public opinion in favor of the Church and its message, attempting to inject more of the message in news releases. In view of the worldwide mission of the Church the Bureau will also seek to give emphasis to its worldwide nature.
4. Enlarge planning for radio and television news coverage, watching for placement of personnel on programs, use of television film shorts, and spot advertising on radio and television.
5. Renew efforts to establish or improve relations with news media personnel, civic leaders, prominent citizens and other thought leaders, especially through cooperation in community activities. One means of accomplishing this will be a wider use of a completely revised handbook on the Church and its activities and teachings, to appear early in 1967.

6. Take increasing advantage of advertising as a powerful tool of communication. Assist in the preparation of evangelistic advertising materials of all types with emphasis on a professional product, and to make these available for use in newspapers and magazines. These materials will include complete evangelistic ads as well as aids for ministers and evangelists in preparing local ads and promotional pieces.

7. Assist in exploring new methods of evangelism keyed to special-interest groups and areas, through such means as community discussion groups, traveling exhibits, and mobile evangelistic units.

8. Strengthen the membership of the church in greater understanding of the church's mission through such means as specially prepared audio-visual materials, articles in church publications, and resource materials.

9. Study the best means of working with and cooperating with all departments of the church in a coordinated approach toward the task of reaching all mankind with the message entrusted to this remnant church.

66/292 HERBERT FAIMANN--HOMELAND STATUS

WHEREAS, Herbert Faimann, presently employed by Middle East College as an industrial head, is a national of Austria who was employed in Lebanon on the basis of a national worker, but now requests that Austria be established as his homeland, it was

VOTED, To pass on to the General Conference the request that Austria be considered the homeland of Herbert Faimann.
