67/1 TURKEY SECTION--REQUEST FOR CLOTHING

VOTED, To pass on to the General Conference Welfare Service the request of the Turkey Section for 100 bales of winter clothing for children.

67/2 VACATIONS -- AUTHORIZATION

VOTED, That regular vacations that are in harmony with the Middle East Division policy be arranged and authorized by the Division treasurer, it being understood that exceptions will be presented to the committee for approval.

67/3 EGYPT SECTION--EMERGENCY APPROPRIATION

VOTED, To grant an emergency appropriation of LL 10, 176.67 to the Egypt Section to be used to make pending Social Security payments for the months July to December, 1966, to be charged as follows:

Emergency Fund LL 7,424.36
Aden Budget Reserve 2,752.31

67/4 BENGHAZI HOSPITAL--X-RAY EQUIPMENT

VOTED, To approve the request of the Benghazi Hospital to purchase X-ray equipment for the new building from funds in hand, it being understood that this will be considered in connection with the 1968 requests for special appropriations. Cost \$15,000.

67/5 BENGHAZI HOSPITAL--AUDITORIUM/CHURCH SCHOOL CONSTRUCTION

- c) Location--Northeast corner of lot with parking area on the west side of the building
- d) Kitchenette available to auditorium

VOTED, To recommend to the General Conference the request of June Soper for a permanent return to the United States effective at the end of the present school year; and further,

To express to Miss Soper our sincere appreciation for her two terms of consecrated and effective service as head of the Music Department of Middle East College.

VOTED, To pass on to the General Conference the request of Middle East College for a man to serve as head of the Music Department.
