67/184 LOTFY ABADIR--COUNSEL REGARDING FINAL SETTLEMENT

Lotfy Abadir, pastor of the Tehran Center church, has a service record of eleven years. He now desires to leave the work temporarily to accept non-denominational work and eventually take advanced studies on his own account. He has requested the Section to make final settlement with him. Since there is no policy covering such a case, the Division committee is asked for counsel. It was

VOTED, To recommend to the Iran Section that no final settlement be made with Lotfy Abadir since he is planning to leave the work on his own volition. Should he obtain a degree at his own expense and later be called back to this Division territory, it appears that the policy "Allowances for Nationals" (MED WP 121, 122) may be applicable.

67/185 GERALD KOVALSKI--PERMANENT RETURN

Gerald Kovalski and family arrived in Iran February 6, 1967. On March 31 Mrs. Kovalski was hospitalized with a serious gastro-intestinal infection. Following this her general health continued to deteriorate and although she was again hospitalized for two weeks beginning April 18, the doctors were unable to make a satisfactory diagnosis. On May 5 the Middle East Division asked the family to go to Beirut where Mrs. Kovalski was interned in the American University Hospital where she received additional medical treatment and minor surgery. The family remained in Beirut for two weeks but on return to Iran Mrs. Kovalski was unable to regain her strength and Brother Kovalski also became ill with a kidney infection. In harmony with the repeated request of Brother and Sister Kovalski, it was

VOTED, To recommend to the General Conference that Gerald Kovalski and family be granted a permanent return to their homeland for health reasons.

67/186 NADIA NASHED--RESIGNATION

Nadia Nashed, an Egyptian national, received travel expense to Karachi to study nursing in harmony with the Nursing Students' Travel policy (MED WP 110) and has since graduation been employed by the Benghazi Hospital for approximately one and a half years. At the time of the Middle East crisis she left Benghazi and does not plan to continue work within the organization. It was

VOTED, That Nadia Nashed's salary be continued to July 31, 1967, and that she be granted the equivalent of an economy air ticket from Benghazi to Beirut. These credits will be applied toward the unamortized portion of the loan granted for her nurses training.

67/187 L. H. COWLES--TRANSFER TO BEIRUT

Since the Middle East crisis it has not been possible for L. H. Cowles to return to Egypt. It was

VOTED, To authorize the transfer of L. H. Cowles from Cairo, Egypt, to Beirut, Lebanon, as of June 15, 1967, and

That he be asked to teach in the Beirut Overseas School.

67/188 W. A. POTTER--TRANSFER TO BEIRUT

Since the Middle East crisis has made it impossible for W. A. Potter to continue his work in Jordan, it was

VOTED, To authorize the transfer of W. A. Potter from Amman, Jordan, to Beirut, Lebanon, as of July 11, 1967, and

That he be assigned to the Lebanon Section for pastor-evangelistic work in Ras Beirut.

67/189 EGYPT SECTION--READJUSTMENT IN REALLOCATION OF FUNDS
