# MIDDLE EAST DIVISION QUADRENNIAL COUNCIL November 13, 1967, 8:30 A.M.

#### DEVOTIONAL SERVICE:

Elder K. H. Emmerson, Treasurer of the General Conference, in the devotional thoughts of the morning, urged the workers to follow the counsel of Paul to Timothy, painting a vivid portrait of what the ideal minister or worker is to be. Timothy was admonished to be strong in the Lord, to be a faithful teacher, and to be a good soldier for his Captain. No good soldier on active service gets himself entangled in business or civilian affairs.

Following the devotional the 9:45 a.m. session convened and Elder J. S. Russell offered prayer.

The Plans Committee presented the following report:

## 67/252 CONCERN

WHEREAS, There is need in every church for a definite program to search for and endeavor to reclaim missing members and former members, and

WHEREAS, Pastors are achieving excellent results in churches where similar plans are now in operation,

VOTED, The following:

- That prompt study be given to the implementation of the following program known as CONCERN.
- II. That CONCERN involve three specific phases: A. REACHING the missing and former members. B. Preparing the church for RE-CEIVING them back into fellowship, and C. HOLDING them in the church.
  - A. REACHING the Missing and Former Members
    - That a survey be made by the local church board in counsel with the pastor to discover all missing members, and former members living in the area. Prime sources for this survey may include church records, lists provided by literature evangelists, and names submitted by members.
    - 2. That the church manifest a genuine concern toward restoring these to its fellowship. This may be accomplished by the following means:
      - a. Through fellowship prayer groups.
      - b. Through CONCERN teams appointed by the Church Board in counsel with the pastor whose purpose would be to demonstrate the church's warmth and eagerness to

establish friendly relationships on a person to person basis.

- ing with such aids as <u>Finding His Lost Sheep</u> by F.W. Detamore, visit assigned prospects using a CONCERN packet. This packet may include the following:
  - (1) Middle East Messenger, Hope or other appropriate literature.
  - (2) A Sabbath School Quarterly.
  - (3) A personal letter by the Section president and/or local pastor.
  - (4) A four to eight page insert with appropriate messages well illustrated.
- d. CONCERN teams will follow-up with weekly visits until the subjects of their concern either return to the church or indicate definitely that they have no interest and prefer not to be bothered. The teams should be limited to two or three prospects each so that this follow-up work may be faithfully done.
- e. Periodic meetings to be held by the pastor with his CONCERN teams to evaluate results, refer special interests or problems, and provide guidance as needed.
- f. The church services should be planned with CONCERN in mind and wherever feasible, Sunday night meetings or other evangelistic services shall be scheduled as reaping meetings.
- g. A CONCERN coordinator should be appointed by the church board to assist the pastor in securing the cooperation of every department of the church in this effort, for example, the Sabbath School through class evangelism, the Missionary Volunteer Department through Friendship Teams, the Publishing Department through its literature evangelists, the Lay Activities Department through its many avenues.

#### B. RECEIVING

- The church members should be conditioned to receive CONCERN prospects back into their fellowship. This will mean
  - a. That the church membership be led into an experience of revival of genuine godliness so that by "example discipleship" it will be in a position to wholeheartedly welcome new members.
  - ship, happiness and genuine Christian concern for others.

c. That each new member be involved at once in some active phase of the church program. "Every one who is added to the ranks by conversion is to be assigned his post of duty." --Testimonies, vol. 7, p. 30.

#### C. HOLDING

- 1. That special effort be put forth to eliminate those conditions that have contributed so heavily toward apostasies in the past. This will mean
  - a. That the members develop a growing fellowship of concern one for another, particularly those who may be in need of special encouragement. Plans may include the Undershepherd Plan, the Guardianship Plan, friendship teams, the buddy system or some similar program that will ensure proper personal interest and follow-up.
  - b. That special care be exercised to assure proper preparation of candidates for baptism or rebaptism.
  - c. That each church member be continually involved in personal soul-winning, remembering that "Where there is no active labor for others, love wanes, and faith grows dim." --Desire of Ages, p. 825.
  - d. That the pastor lead out in CONCERN by faithfully shepherding the flock. This calls for frequent personal visitation and a preaching ministry that will feed his congregation with the vital and practical themes of the Word of God that are to prepare a people for the coming of Jesus.
- III. That distribution of the CONCERN packet be through the Middle East Press with promotion spearheaded by the Ministerial Association of the Division.

# 67/253 MISSIONARY INVOLVEMENT OF ADVENTIST MEN

WHEREAS, The mission of the church is so wide and so great as to require the utilization to the fullest of all the talents and resources of its lay membership, and

WHEREAS, The men of the church have many special skills which can be applied and further developed in fulfilling the world mission of the church of God in these last days, and

WHEREAS, The fuller involvement of men in the missionary program of the church will bring to them great spiritual blessings and through them to the church and the community as well, and

WHEREAS, We are instructed that "we want men in the church who have ability to develop in the line of organizing and giving practical work to young men and women in the line of relieving the wants of humanity, and working for the salvation of the souls of men, women, youth, and children," -- (Welfare Ministry, p. 105)

VOTED, 1. That Adventist Men concentrate their efforts in these areas of missionary service for which they are especially qualified:

- a. Lay preaching efforts
- b. Work for male prisoners
- c. Disaster relief services such as Rescue squad and emergency first aid Mass feeding Clean up squads Repair squads
- d. Community Health and Welfare Projects such as
  Conducting adult education classes
  Using skills to help needy families in the community
- 2. That where there is a sufficient number of men in a local church, Adventist Men work together as a group under the direction of the Department of Lay Activities.
- 3. That wide circulation be given to the Lay Activities leaflet No. 21, outlining these missionary activities for men.
- 4. That local fields arrange, on a pilot basis, a vacation retreat for business, professional, and other men with leadership and speaking ability, to be held at Section owned camps or institutions, for a period of at least three week days with twenty hours of instruction and study, or a weekend retreat including twelve and one-half hours of classwork, following a course of study to be prepared by the Department of Lay Activities in consultation with the Medical Department.

# 67/254 HEALTH AND WELFARE PROGRAM FOR YOUNG LADIES

WHEREAS, In the deep, unmet needs -- physical, emotional, and spiritual -- of people of all ages in every community, Seventh-day Adventist Christians recognize a cry for help that they can best answer and must not ignore, and

WHEREAS, The Health and Welfare Services of the church are as broad as human need and are designed to give opportunity for every individual within the church family to develop those Christian qualities which project Christ's love to those around them, and WHEREAS, The strength, enthusiasm, and talents of the young women of the church will bring new vigor, life, and effectiveness into the health and welfare program of the denomination,

- VOTED, 1. That we urge and encourage the younger women in our churches to join a working group engaged exclusively in Health and Welfare Services projects, specializing in and concentrating upon personal ministry to individuals and families in need within the community.
- 2. That pastors and lay activities leaders initiate the organization of this group and that they give encouragement, support, and guidance, especially during the early months of the life of this organization.
- 3. That the leader of this group be elected by the church in the usual manner, except at the time of organization, when they may choose their own leaders, subject to church board approval.
- 4. That provision be made for the leader of this group to be a member of the Lay Activities Council of the church, and that this service group closely coordinate its work with other Health and Welfare Services groups within the church (Dorcas Welfare, Adventist Men) under the overall direction of the Lay Activities Council.
- 5. That the Lay Activities leader of the church, or his assistant, be responsible for coordinating, counseling, and encouraging these Health and Welfare Services groups of the church.
- 6. That those women in our churches desiring to do handiwork, be urged to concentrate such efforts in making items desperately needed by those unable to purchase them (bandages for lepers, layettes, new clothing for children, etc.).

## 67/255 TELEPHONE EVANGELISM

WHEREAS, We ought to use every possible avenue for sharing the message of this hour, and

WHEREAS, Telephone evangelism is finding success with such programs as Teen Dial, Slim Line, Drinker's Dial, Smoker's Dial, Dial a Prayer and Dial Your Family Bible (as used in the Southern Union), and

WHEREAS, Telephone evangelism offers the following unique advantages:

- 1. Truth perpetually available 24 hours a day.
- 2. An electronic secretary on duty 24 hours a day to record requests of the interested or persons in stress.
- 3. An avenue to homes in lands where radio and television time are not available to the church.

- 4. A "private, in-the-ear" approach to people who would not want to be seen watching or listening to a religious program or attending a church service.
  - 5. Entrance to all homes with telephones.
  - 6. Entrance to business offices at any time.
- 7. The message can be redialed and heard over and over again, so that an important Scriptural reference is not missed because it was given but once.
- 8. A listener can hear something he likes and urge someone else to dial and listen to it, because it has not gone off the air.
- 9. The service can be linked to existing Adventist radio and TV programs; the Bible courses can be a part of their service.
- 10. It pulls names by asking for an immediate response to the message the listener has just heard, and his reaction is automatic.
- 11. It can provide numerous bonafide-interest names for literature evangelist contacts as well as lay evangelism contacts as Bible courses are completed.
- VOTED, 1. That the Ministerial Association give study to the implementation of telephone evangelism on a church-wide basis with guidelines established to assure quality and sound coordinated operation. These would give direction in the areas of:
  - a. Brevity
  - b. Effectiveness via a personal approach
  - c. Technical acceptability
  - d. Coordination with existing Bible correspondence schools
  - e. Well-planned follow-up
- 2. That study be given the existing types of electronic equipment designed for this type of evangelism and specific information be prepared on its availability, qualifications, and cost; this information to accompany the guidelines.

# 67/256 LAY ACTIVITIES TRAINING COURSES

VOTED, That every church be urged to conduct at least two soulwinning training classes during the year 1968, using one of the two available courses:

- 1. Training Light Bearers (10 lessons)
- Leadership Series (6 booklets)

## 67/257 SOUL WINNING THROUGH THE INGATHERING PROGRAM

WHEREAS, The annual Ingathering Crusade is one of the major missionary endeavors of the church, resulting in millions of contacts and presenting to workers and members excellent soul-winning opportunities in house-to-house and business visits, and

WHEREAS, We have been given this inspired message that through Ingathering "men and women of all classes have been reached and the name of God has been glorified," (Christian Service, p. 167) and "only a moment of time, as it were, yet remains. . . Now that we are standing upon the very verge of the eternal world, holding the truths we do, having so great light, so important a work, we must double our diligence." (Ibid., pp. 52, 79),

- VOTED, 1. That each section and church emphasize Ingathering as personal evangelism, stressing the opportunity of making every call a missionary contact for Christ.
- 2, That Ingathering contacts be made a missionary adventure, following the admonition, "search diligently for perishing souls" (Counsels on Stewardship, p. 189), by taking time to answer questions, to ascertain interest, needs, and problems of individuals contacted, to secure their name and address, and to direct their attention to the free service offered in the Ingathering magazines.
- 3. That the Department of Lay Activities prepare an interest report in pad form to be used by every Ingathering worker to check categories of interest, problems and services rendered.
- 4. That we accept this missionary objective during the Ingathering Crusade: One interest report from each Ingatherer to be given to the church Lay Activities leader on each Ingathering occasion, and that a tabulation of these forms by the church be sent to the Section office and forwarded to the Division.

#### 67/258 HEALTH EMPHASIS IN OUR CHURCHES

In harmony with the instruction given the Church that labor for our people should include health presentations as an important part of the gospel,

VOTED, That in planning programs for their churches, ministers be encouraged to give due emphasis to health in their yearly planning, and further,

To recommend to the Medical Department of the Middle East Division, that study be given to a plan whereby workers around the field might be properly instructed in our health message so that they, in turn, can instruct their respective church members and community in proper health.

## 67/259 LOCAL CHURCH HEALTH COUNCIL

WHEREAS, A means of bringing health evangelism, health education and practical principles of healthful living to our laymen and our communities is needed.

VOTED, 1. That all churches provide for the election of a health secretary.

- 2. That those churches having sufficient members elect a health council.
- 3. That the health council work in close cooperation with other departments of the church by giving counsel, by providing training and by contributing professional skills in the carrying on of church activities.
- 4. That professional assistance, where available, be provided the community in times of emergency or disaster.

#### 67/260 CHURCH-SPONSORED HEALTH PROJECTS

WHEREAS, We have been counseled that "every church should be a training school for Christian workers. . . There should be schools of health, cooking schools, and classes in various lines of Christian-help work. There should not only be teaching, but actual work under experienced instructors. Let the teachers lead the way in working among the people," (Ministry of Healing, p. 149)

- VOTED, 1. That all churches be encouraged to develop appropriate training projects for the fulfillment of these objectives, as may be indicated by the needs of their respective members and communities, and as permitted by their resources, and
- 2. That wherever possible courses be conducted for the training of Home Health Aides which would include instruction in Home Nursing, First Aid, Healthful Food Preparation and Seventh-day Adventist Philosophy of Healthful Living.

Adjourned at 11:00 a.m. with prayer by George Terzibashian.

The afternoon session convened at 2:30 p. m. Philip Srour offered the opening prayer.

#### DEVOTIONAL SERVICE:

Following is the report presented by the Finance Committee. (Actions 67/297 - 67/313)

## 67/297 HOME STUDY INSTITUTE -- AIRMAIL POSTAGE EXPENSE

VOTED, That employing organizations grant reimbursement to workers on lessons and study material airmail postage expense incurred by them or their children enrolled in Home Study Institute courses.

## 67/298 RETURNING NATIONAL WORKERS--ALLOWANCES

VOTED, To amend the Allowances for Returning National Workers Policy (W P 121) Section 3 to read as follows:

3. The Division shall pay freight shipping expenses. . . up to 2,000 pounds for a family. In case a worker does not transport his maximum weight, he shall receive an allowance of \$20.00 or its equivalent at the current rate in local currency, for each 100 pounds of unused weight privilege.

#### 67/299 RENT CEILING--BEIRUT

VOTED, That MED action 66/285 setting rent ceilings for Beirut be interpreted to refer to the metropolitan area rather than to that included within the city limits.

#### 67/300 EDUCATIONAL ALLOWANCE--CHILDREN OF WORKERS

VOTED, That in the application of the Educational Allowance Policy (MED W P 103, 109) the employing organization send the allowance to the denominational schools involved instead of having the schools charge the employing organization.

#### 67/301 DAILY ALLOWANCE--CLARIFICATION

VOTED, That we request the Division officers to give further study to the problem of equitable daily allowances in each Section and bring a report of their study to a Division committee with full representation.

#### 67/302 TRANSFER OF WORKERS BETWEEN SECTIONS

VOTED, That the Moving Policy (MED WP 106, 107), be amended by substituting the following:

- 1. When a worker with an established home accepts an official call to labor in a Section other than the one in which he currently lives, the following expenses shall be reportable:
  - a. The fares of the worker and his dependent family to his new field of labor, the class of travel being determined by the calling organization with the concurrence of the Division.
  - b. Freight, cartage, handling and necessary packing and crating on authorized weight of household goods and personal effects, not including automobiles, articles for sale or articles carried for others, from the worker's home to the place of his new appointment, on 1,800 kg. gross weight including crating for couples and 200 kg. additional for each dependent child, (900 kg. for single workers).
  - c. Customs charges actually paid on authorized weight allowed on household goods and personal effects actually shipped, not including automobiles, moving-picture equipment, cameras, films, field glasses, radio equipment, and other equipment of a similar nature, articles for sale or gifts, or articles carried for other

persons. In making settlement where the worker has more than the authorized weight, customs duty paid will be prorated on the same basis as shipping charges. The calling organization should carefully instruct the worker with regard to prohibitions and special problems connected with his move.

- d. In cases where a worker elects to take to the field less than the freight allowance provided for above, he shall be compensated in cash in the currency of the country from which he is called at the rate of LL 100.00 per hundred kilograms or its equivalent value in local currency, transferable at the fixed rate covering the unused portion of his authorized freight allowance.
- e. All-risk insurance on household goods and personal effects with limitations as stipulated under "c" above. It is required that insurance must be secured in every case, unless the Section specifically and in writing agrees to pay for damage or loss sustained in transit.
- f. A baggage allowance of LL 100.00 for each full-fare ticket and one half this amount for each half-fare ticket shall be granted when the worker at the request of his employing organization proceeds to his new field of labor by air.
- g. Workers are expected to make a carefully detailed statement of the actual amount paid for each item and class of expense. Receipts should be obtained from the companies concerned for the charges paid, and in case of freight the receipt should show the weight of the shipment and the rates charged. These receipts should be attached to the expense reports submitted upon arrival in the field.
- h. A cash allowance to cover other expenses not included in this policy, and to assist the worker in setting up his new home of LL 250.00 plus LL 50.00 for each dependent child (LL 150.00 for a single worker).
- 2. In applying the above policy to single workers with no established home, actual expense for freight, etc., up to the weight limit allowed by the policy and the other provisions applicable to single workers with established homes as outlined in paragraph 1 will be paid, but no allowance for unused weight will be made.
- 3. The expense of transferring a worker from one Section to another within the Division, whether he was formerly employed or not, shall be shared equally by the calling Section and the Division.
- 4. When a worker with an established home is requested by his controlling committee to move within the Section, the provisions of this policy shall not apply, but the local field shall pay the moving expense, including payment for damage to household goods which may be sustained in transit, and a cash allowance of LL 100.00 for a family and LL 50.00 for a single worker to cover incidental expenses and to assist the worker in setting up his new home.

## 67/303 ELISEO OLIVERIO--FREIGHT ALLOWANCE

When Eliseo Oliverio, Benghazi Hospital laboratory technician, and his family came to Benghazi from the Philippines there was a freight allowance policy only for Filipino physicians' families and single workers. Later, a policy was adopted affecting all Filipino workers. It was

VOTED, To allow the Eliseo Oliverio family the freight allowance according to the new policy for Filipino families.

## 67/304 MEDICAL EXPENSE ASSISTANCE

VOTED, That the Medical Expense Assistance Policy, MED Minutes 66/281, page 1392, (MED W P page 98) be amended as follows:

"1. Workers having medical and/or dental and/or optical and/or hearing aid and/or obstetrical expense may be allowed 75 per cent of such expense; such allowance to be made only on receipted medical bills for which the worker has actually made payment. Assistance on the purchase of pharmaceuticals, including vitamins, reported on medical allowance sheets shall be allowed only if purchased on a physician's prescription or with a physician's written order in the case of nonprescription purchases. Prescription purchases must bear the prescription number or other identifying marks. Assistance as provided for above may also apply on the expense of medical and orthopedic appliances when prescribed by a qualified physician."

## 67/306 SUSTENTATION POLICY--REVISION

VOTED, To amend the Sustentation Policy, section 43, by the addition of another paragraph so that the entire section would read as follows: (Underlined portion is added)

43. Sustentation beneficiaries receiving government social insurance payments from funds provided by the denomination will receive sustentation payments based on a percentage reduction equal to the percentage of salary paid into the account by the denomination.

It is understood that in the application of this policy the combined monthly payments from sustentation and social insurance shall not be less than the regular sustentation amount applicable plus the amount being paid per month by the worker, at the time of going on sustentation, into the social insurance fund.

#### 67/307 SUSTENTATION RATES

VOTED, To rescind paragraphs "b" and "c" of action 67/142 entitled Sustentation Rates--Calculation Formula Revision affecting the Sustentation Rates policy (W P 139) and substitute the following:

- "b. The monthly family rate of sustentation for fifteen years of service be set at 24% of the maximum rate in the Salary Scale received at any time by such worker up to the maximum rate for an ordained minister, and that for each additional year of service from fifteen to forty there be added 1.6% of this rate, making a maximum of 64% of the 100% salary level for forty or more years of service.
- "c. The monthly single rate of sustentation shall be three-fourths of the monthly family rate (18% of the maximum rate received at any time by the worker for fifteen years of service and 1.2% of this rate for each additional year of service from fifteen to forty), making a maximum of 48% of this rate for forty or more years of service.
- "d. In no case is the actual sustentation rate to exceed 75% of the amount currently being paid as the maximum wage for workers of the category in which the beneficiary was last employed."

# 67/308 SUSTENTATION POLICY-EMPLOYMENT OF PERSONS OVER THIRTY-FIVE

VOTED, That the Middle East Division Working Policy page 124 be amended to read as follows:

"In the employment of workers. . . (First paragraph as at present)

"Employment of Persons Over Thirty-five Years of Age. -- It is the general plan of the denomination to accept for employment individuals who are not more than thirty-five years of age. Special care should be used in bringing individuals into service who are more than 35 years of age. In the case of those who enter the employ of denominational organizations at the age of (36) 41 years to (45) 50 years inclusive, after May 1, 1955, on becoming eligible for benefits of the Sustentation Fund, the base rate shall be reduced 2% in the case of those employed at age (36) 41, 4% for those entering denominational employ at age (37) 42, etc., to age (45) 50 as per the following schedule:

"Physicians and dentists who have had additional training and experience above their regular course of study may enter employment at any time prior to forty years of age without any reduction from any sustentation service credit to which they may be entitled, it being understood that the appointment of any physician or dentist under this arrangement shall be made in consultation with the General Conference officers. If such appointment is approved, the reduction of 2 per cent from any sustentation benefits to which the physician or dentist may be entitled would begin after the age of forty years and continue at the rate of 2 per cent per year to age fifty.

"After May 1, 1955, those entering denominational employ after age (45)  $\underline{50}$  shall in no case become eligible for Sustentation Fund benefits regardless of the number of years of service to the denomination or their future state of health and no percentage shall be paid to the Sustentation Fund on the salary of such workers."

# 67/309 SUSTENTATION POLICY--SERVICE CREDIT FOR WORKERS ON STUDY LEAVE

VOTED, That paragraph 26, page 137 MED Working Policy be amended by adding the following:

"Workers on Study Leave. -- c. It is recognized that sustentation service credit is granted to a worker for the time he is given a leave of absence for additional training provided his employing organization continues denominational salary during the leave of absence.

- "d. Service credit may also be granted to an individual who has been in the employ of the denomination, and his governing board or committee recommends him for further training on the doctoral level and grants him a leave of absence for this purpose, without denominational financial assistance (or with less than full denominational compensation), under the following conditions and limitations:
- "1. A maximum of two years service credit may be granted for such leaves, and this only if the individual returns to denominational employment as soon as his graduate study is completed.
- "2. The worker must complete the doctoral degree in order to receive such service credit.
- "3. The employing organization shall pay into the sustentation fund an amount equivalent to that which would have been paid into the fund had the worker been on full denominational salary during the time of his leave.

"4. The provision for the granting of service credit according to the stipulations of section (b) may be applicable to the worker whose governing board or committee recommends him for such further training after January 1, 1968."

### 67/310 SUSTENTATION POLICY-SIX MONTHS' CONTINUANCE OF SALARY

VOTED, That the following be substituted to replace paragraph 30, page 137, Middle East Division Working Policy:

"30. Any denominational organization employing as a regular worker a former sustentation beneficiary, shall not be required to carry such worker for a period of six months after active work ceases, if he has given less than ten years' service to the cause since being a beneficiary and because of failing health or having reached the retirement age is again granted sustentation."

(Renumber the succeeding paragraphs.)

#### 67/311 SUSTENTATION POLICY--SERVICE CREDIT FOR WIFE

VOTED, That the Sustentation Policy, page 140, MED Working Policy, be amended by adding a new section following section 39, as follows:

"40. The service rendered to the denomination by the wife of a beneficiary while he is receiving a family rate of sustentation which recognizes her as a dependent, shall not be recognized as service on which her eligibility to the fund shall be based or the rate of sustentation she might receive in case at a later time she finds it necessary to apply for sustentation as a widow. However, in case the family chooses to accept an amount not to exceed the single rate during the time that the wife is engaged in denominational service, her service may be regarded as active service on which her eligibility and her rate may be based should she find it necessary at a later time to apply for sustentation."

(Renumber the succeeding paragraphs.)

### 67/312 SUSTENTATION POLICY--ELIGIBILITY AFTER BREAKS IN SERVICE

VOTED, That the Sustentation Policy, MED Working Policy, page 136, be amended by substituting the following in place of section 25:

"25. An employee who from choice or preference withdraws from employment but who re-enters the employment of the denomination, may be considered eligible for assistance from the Sustentation Fund under the following conditions:

"For each year he has been out of the employment of the denomination, an additional year of service credit above the minimum of fifteen years is required for eligibility. The number of additional years of service required above the minimum because of withdrawal from employment shall not exceed ten irrespective of the length of the break in service." (Note: The provision of this paragraph is to be applicable to sustentation applications filed after January 1, 1968.)

## 67/313 ANTOINE ZAHLANE--EDUCATIONAL LOAN

VOTED, That the educational loan to Antoine Zahlane be increased to the equivalent of LL 2,000.00 for his schooling in Italy for the present school year.
