It has been brought to the attention of the North American Division Administration that the pricing of subscription books in various sectors of the division is varied and inconsistent. This could have serious implications for the publishing work, especially in view of past experiences. Before appropriate steps can be taken, the situation needs to be carefully evaluated to determine the current status in regard to both trade factors and legal consideration. Therefore, it is

VOTED, To appropriate the amount of \$10,000 to cover the cost of preparing a legal memorandum on the pricing of subscription books published by Pacific Press Publishing Association and Review and Herald Publishing Association. The funds will be taken from the unused amount in the Publishing Committee balance in the current budget.
