MT. ZION SEVENTH-DAY ADVENTIST CHURCH, NORTHEASTERN CONFERENCE, ATLANTIC UNION CONFERENCE—BUILDING AND FINANCIAL PLANS

VOTED To approve the financial plans of the building project for the Mt. Zion Seventh-day Adventist Church, located at 64 Marlboro St., Hamden, Connecticut 06517, and noting the following variances to policy, with respect to the financial plans of this project:

- 1. External financing will be from a commercial bank and not the Atlantic Union Conference Revolving Fund.
- 2. There are no plans for financial participation by the conference in this project; however, the conference will sign for the project and assume liability. (The property and building will be registered to the Northeastern Conference Corporation, as per policy.)
- 3. The amount of the loan to be issued by the bank exceeds the normal limit specified when looking at tithe income; however, the Northeastern Conference and the Atlantic Union Conference support this project based on an analysis of the church's past giving patterns, as well as the level of commitment on the part of the membership.

Type of Construction and Project: This project is an estimated 33,720 sq. foot church building complex with sanctuary, mezzanine, gymnatorium and other support facilities.

Life Safety: The building is planned to be a one-hour fire structure in accordance with National Building Code Fire Protection Association (NFPA) Life Safety Code.

Recommendations from Adventist Risk Management:

- 1. That the Architect, General Contractor and all Sub-Contractors provide General Liability Certificates of Insurance Coverage, naming the Atlantic Union Conference of Seventh-day Adventists and the Northeastern Conference of Seventh-day Adventists, as an Additional Insured for at least \$1,000,000.00, in accordance with NAD Working Policy P 50 and Workers' Compensation Coverage, as required by Law.
- 2. That the sponsors require evidence of liability coverage up to the cost of projected building by all professional contractors and sub-contractors working on the above-mentioned project.
- 3. That the sponsors require that the General Contractor provide evidence of a performance bond for the completion of this project, in accordance with the NAD Working Policy, P 50. And full compliance with all provisions of North American

Division Working Policy, National Fire Protection Association Code, State and Local Building Codes.

4. That the sponsors visit the Adventist Risk Management, Inc. website (www.adventistrisk.org) or contact office for further risk management planning solutions.

COLUMBIA UNION (POTOMAC CONFERENCE)— EXCEPTION TO POLICY

Recently, the Potomac Conference Corporation and the Potomac Conference Executive Committee requested the Columbia Union Revolving Fund (CURF) to grant to them a \$5.5 million dollar loan to build a new facility which will service the Southern Asia congregation on ten acres of property located on the corner of Old Columbia Pike and Randolph Road, (Commonly referred to as the Conley Property) held in trust by the Potomac Conference Corporation. However, CURF denied the loan request since the construction project exceeds the North American Division *Working Policy* directive P 15 60 6a which states that borrowing may be authorized up to the following limits: the lesser of 200 percent of the annual tithe, or 50 percent of the cost of the project. Moreover, a \$5.5 million dollar loan would considerably impact the debt capacity of the Potomac Conference.

VOTED, To grant an exception to NAD P 15 60-6a and P 15 50-6c to the Potomac Conference Corporation for the Columbia Union Revolving Fund (CURF), which will grant to the Southern Asia congregation a \$5.5 million dollar loan to build a new facility on ten acres of property located on the corner of Old Columbia Pike and Randolph Road, (Commonly referred to as the Conley Property), subject to the following terms and conditions:

- 1. The balance of a loan due on the Conley property shall be paid in full,
- Pursuant to NAD Working Policy P 15 65, Building Projects, and the Potomac Conference shall submit the building plans to the NAD Building, Borrowing, and Blueprints Committee and the North American Division Committee for administration (NADCOA), with the final approval of the building plans by NADCOA, pursuant to NAD Working Policy P 15 60, Debt Control and
- 3. Final approval by the North American Division Committee (NADCOA).

LOW POWER FREQUENCY MODULATION (FM) STATIONS— DENOMINATIONAL STATUS—TEMPORARY EXCEPTION TO POLICY

VOTED, To grant a temporary exception to NAD Working Policy C 47 10 for Low Power Frequency Modulation (FM) stations that meet the following criteria:

- 1. The corporate membership shall be the local church board.
- Programming shall be provided through an agreement with LifeTalk Radio or other radio ministry with denominational status and which is listed in the current Adventist Yearbook.
- 3. The financial records shall be subject to audit by GCAS.
- The corporation shall maintain a contract with the local conference for the lease and use of property, facilities, and/or equipment owned by the conference.
- The station agrees to operate in harmony with Adventist beliefs and standards and in cooperation with the overall mission and objectives of the local conference.
