THE BRITISH COLUMBIA CONFERENCE

A general report of the late session of the British Columbia Conference, which was held at Pitt Meadows, December 25-29, 1913, has already been published in the Tidings of January 14. No doubt our people in that field will also appreciate a brief report of the actions taken at that time. We had hoped to print these in an earlier issue, but have been delayed until this time.

The first meeting of the session convened on the morning of December 26. A most appropriate hymn, "Crown Him Lord of All," was heartily joined in by the congregation, and throughout the entire session it seemed to be the earnest endeavor of every delegate and visitor to heed the injunction contained in the sentiment of this beautiful hymn.

In opening the business part of the first meeting, the chairman spoke of four churches which had been organized since the last session of the Conference. These are located at Penticton, Lumen, Nanaimo and Vancouver. It was voted unanimously to admit these churches to the care and fellowship of the Conference. Thirty-seven delegates answered to the roll-call at the first meeting and others were seated at later intervals during the session.

The President's address was given at the first meeting and was one of the interesting features of the session. The work of the past eighteen months was included in this report, as the last session was held at Kamloops in the summer of 1912. We expected to publish this report in full, but for some reason it has not yet reached our office. The report of the treasurer is given in this issue.

By vote of the delegates, the President, in counsel with the Conference Committee, was authorized to appoint the standing committees for the Conference. The members of these committees were announced at the second meeting as follows:

Committee on Nominations: C. E. Wood, J. Rottacker, J. Lowther, E. S. Horsman and George Freeman.

Committee on Plans and Resolutions: E. R.

Potter, H. E. Giddings, A. O. Burrill, W. L. Manfull, H. Berg, Wm. McLeod and C. O. Smith.

Committee on Credentials and Licenses: J. L. Wilson, J. G. Walker and H. S. Shaw.

Committee on Adjustment of Fares: J. L. Wilson, Bertha Lofstad and C. O. Smith.

The Committee on Nominations rendered its report at the third meeting, which was later adopted as follows:

For President, J. G. Walker; Secretary-Treasurer, C. O. Smith; Field Secretary, to be left for selection by the Conference Committee; Sabbath-school Secretary, Bertha Lofstad; Missionary Volunteer Secretary, Lydia Stickle; Educational Secretary, C. O. Smith; Field Missionary Secretary, E. R. Potter; Executive Committee, J. G. Walker, J. Rottacker, A. H. Nicholson, C. E. Wood, Chas. Koelsche, E. R. Potter and George Freeman (Elder A. O. Burrill to act as committee counsellor); School Board, to be composed of the Executive Committee with the Educational Secretary and the Principal of the Academy; Delegates to Union Conference, J. G. Walker, J. L. Wilson, C. O. Smith, J. Rottacker, E. R. Potter, Bertha Lofstad, H. E. Giddings, A. O. Burrill, and two other delegates to be appointed by the Conference Committee if the funds in hand warrant.

The report of the Committee on Credentials and Licenses was adopted as follows:

Credentials: J. G. Walker, J. L. Wilson, A. O. Burrill, Luther Warren, H. E. Giddings and Jacob Rottacker.

Ministerial License: E. R. Potter.

Missionary Licenses: C. O. Smith, Bertha Lofstad, Lydia Stickla, John Lowther, Henry Pierce, George Toombs and Henry Berg. All other names referred to the Conference Committee.

During the session the Committee on Plans submitted fifteen recommendations for the consideration of the delegates. Ample time was spent in helpful and interesting discussions of the subjects presented, and after careful and prayerful consideration, the recommendations were unanimously adopted.

Resolutions Adopted.

Whereas, The President's report shows that the good hand of God has been manifest in the degree of prosperity which has attended the work of the British Columbia Conference the past year in preserving the lives and health of the workers and people and giving them souls for their hire,—

1. Resolved, That we as a conference express our heartfelt thanks to our Heavenly Father to whom all the praise and glory belong, and that we reconsecrate ourselves to him for more diligent and faithful service in the future.

For the protection of Church Treasurers and the prevention of permanent mistakes in his accounts,-

2. We Recommend, That at each quarterly business meeting the names of those paying tithe during the quarter shall be read before the church together with the amounts paid by each.

Whereas, The needs of the mission fields are greater than ever before, and to meet these needs the General Conference has raised the quota of offerings for missions for each member from fifteen to twenty cents per week; and,—

Whereas, We will need to increase the amount paid the coming year in order to reach the goal,-

3. We Recommend, That the treasurer of each Church make a report at the end of each quarter of the entire amount received and the average per member.

Whereas, The Lord has spoken to us of the canvassing work and its importance as an evangelizing agency, therefore,—

4. We Recommend, That more earnest efforts be made to enlist young and old who are fitted to take up the sale of periodicals and home workers' books and our large subscription books.

Whereas, The Spirit of Prophecy has given us much instruction, and wise generalship demands

that our church members must be educated in church duties, and in personal labor for their neighbors and friends,—

5. We Recommend, That Church Institutes be held with as many churches in our province as possible during the winter months.

Since there are 16,000 Germans in this province and this number is increasing by immigration,—

6. We Recommend, That the Conference give attention to this people by employing a German laborer who shall give his time to this line of work.

7. We Recommend, That Brother Pierce, our Indian worker, labor among some of the Indian tribes in the southern part of the province so that he may come more directly under the supervision of the conference.

Whereas, The Spirit of Prophecy has told us that the end is much nearer than many of us realize, that Satan is manifesting great power and malignity knowing that he has but a short time; and that the children and young people of those who believe the third angel's message are his special prey, and that the results of indifference are seen in a decline in spirituality and zeal for the cause on the part of the young, many of whom are going to the world and giving their talents to the enemy; therefore,—

8. Resolved, That we awake out of sleep and gather the lambs into the fold by putting forth efforts, commensurate with the eternal interests involved, provide home and church schools so far as possible, and strengthen our conference school that it may better meet the needs of the work. And that our young people may gain an inspiration and fitness to devote their lives to the cause of God; that our conference school be placed on a self-supporting basis to the end that confidence may be established in its stability,—

(a). By stirring up our people to the importance of sending suitable young people to the school.

(b). By adopting such a policy that the school will be able to furnish employment to such students as may need to pay their own expenses in this way, and,—

(c). By discontinuing all work above the tenth grade, after the present school year closes, and thus bring our school into line with the principle recommended by the General Conference.

9. Resolved, That we as a conference, give more attention to the studying and practice of the teachings of the Spirit of Prophecy as manifested among Seventh-day Adventists.

Whereas, The Review and Herald is our Church paper, and an index to the progress of the cause in all the world, therefore,—

10. Resolved, That we urge all our people to become permanent subscribers to the same. Whereas, Elder J. L. Wilson has received an urgent invitation to connect with the Alberta Conference, and he feels he should answer the call, therefore,—

11. We Recommend, That Elder Wilson be released to go to Alberta, and that we assure Brother Wilson and his family of our love for them, and bid them God-speed in their new field.

Whereas, The population of this province is composed of many nationalities to whom we are debtor, and,—

Whereas, We have literature in most of these languages; therefore,-

12. We Recommend, That steps be taken to give the message to all so far as possible, by the distribution of such literature, and by visiting the needy and interested.

Whereas, The Medical Missionary Work is an important branch of the work, and,-

Whereas, A knowledge of the proper combination of foods is necessary, and the science of simple treatments are essential; therefore,—

13. Resolved, That this phase of the message receive due consideration at our Church Institutes, and that our people make a careful study of these subjects and how to do Medical Missionary Work among their friends and neighbors.

14. Since our Tract Society is indebted to the Pacific Press Publishing Association to almost the amount of \$1,000, and that we have pledged ourselves to do our best to reduce the debt greatly by March, 1914, we urge our people to settle their accounts with the Tract Society at once, and that in future all accounts be paid monthly.

15. To encourage our people in the distribution of our books and the purchasing of them through the Church Missionary Society, we ask that the discounts recommended by the General Conference be adopted by our Tract Society.

"More impressive than any other, was the closing scene of our Conference. Kneeling on the rostrum among his Brethren, Elders Walker, Wilson and Giddings, Brother Jacob Rottacker was ordained to the sacred calling of elder and minister. Elder Shaw took the leading part and impressed upon all others the solemn responsibility of one holding this office."

At the close of the last meeting motions were introduced from the floor, tendering votes of thanks to the Church and Academy at Pitt Meadows, for their kind hospitality, and to the Canadian Pacific Railway for their kindness and the benefits received from them, which favors were greatly appreciated by all who attended the meeting.

There are still a number of pledges that are due, and we trust will be redeemed soon, as we must purchase some camp-meeting equipment in the near future.

We have received from the McLean Church an order for forty copies of the "Signs Weekly," to be sent for six months to as many different persons. Why cannot every church make up such a list? Each copy costs but sixtyfive cents. Surely every member could pay for at least one copy. What church will be next?

One brother who is not yet a church member sends us several dollars to purchase literature for city work. This is a needy point in our work. It costs considerable money to pay for a club of Signs like the one being used in Regina at present by Elder Mackintosh. Are there not others who would deem it a privilege to help in this work?

TEMPERANCE WORK IN SASKATCHEWAN

It was the privilege of the writer to attend a recent meeting of the local temperance workers who have enlisted in the "Banish the Bar" campaign. This meeting was called to consider the organization of the temperance forces of the city into a large committee in order to prosecute systematically and vigorously the temperance cause in view of the vote to be taken in July, 1915, on the Bill to "Banish the Bar."

A resolution was passed requesting that each church and organization in sympathy with this movement place representatives on this committee. Though the pro rata basis was established to indicate the number of representatives to be secured from each church, or sympathetic organization, yet the resolution calls for no less than three persons from any organization without regard to numbers.

We are glad to be able to co-operate with this endeavor in the city of Regina. But we are also glad to know that our people in all parts of the province may co-operate in this great campaign against the dreadful evil of intemperance. It is the plan to organize the temperance work in Saskatchewan in such a manner that every community will have a clear conception of its privileges and its duties in behalf of this most important effort.

The Temperance Instructor for 1914 is just off the press. The merits of this publication we all know. Brethren and Sisters, shall we not redouble our efforts in Saskatchewan in the circulation of this magazine? Send in your orders right now for a large supply.
